Staff Recommendation: Approve vacation of drainage easement.

MAPC Recommendation: Approve vacation of drainage easement. (unanimous)

Background: The applicants are developing the lots in this subdivision. Actual construction of the development has shown that the drainage easement is wider than actually needed. The intent is to vacate 5 feet of the 15 foot platted drainage easement so that the full rear yard area is open and unencumbered for use by the lot owners.

The Subdivision Committee and MAPC both approved the vacation. No members of the public addressed the MAPC in opposition to this request.

Recommendations/Actions: Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order; recording costs to be billed to: 150029-2909

5. The vacation of the drainage easement described herein should be approved.

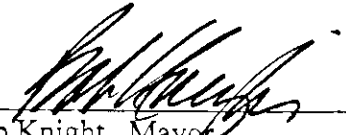
