Staff Recommendation: Approve vacation of maintenance access easement.

MAPC Recommendation: Approve vacation of maintenance access easement. (unanimous)

Background: This vacation petition involves a platted maintenance and access easement in the Bridgeport 3rd Industrial Addition near 37th Street North and Ohio Street. Due to an expansion of storage tanks by the existing business on the property, Home Oil Company, Inc., the maintenance and access easement needs to be removed. It is no longer needed because of the present use of the property.

The Subdivision Committee and MAPC both approved the vacation conditioned upon providing substitute easements for the utilities in the area. The substitute easements have been submitted. No members of the public addressed the MAPC in opposition to this request.

Recommendations/Actions: Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; accept the dedication of the substitute Utility Easements; authorize the Mayor to sign the Easements; and record both the certified copy of the Vacation Order and the Utility Easements; recording costs to be billed to: 150029-2909

VACATION ORDER

NOW on this 9th day of December, 1997, comes on for hearing the petition for vacation filed by Tom Olsen, praying for the vacation of the following described maintenance access easement, to-wit:

A 15' wide maintenance and access easement described as: Commencing at the southeast corner of Lot 2, Block 1, Bridgeport 3rd Addition, Wichita, Sedgwick County, Kansas; to a beginning point 100' North 0°29'58" West, to a point 365' North 89°45'13" West, to a point 444.34' North 0°29'58" West, to a point 15' North 89°37' East, to a point 429.34' South 0°29'58" East, to a point 350' South 89°45'13" East, to the point of beginning 15' South 0°29'29'58" East; also a 15' wide maintenance and access easement described as commencing 801.06 feet south of the northeast corner of Lot 2, Block 1, Bridgeport 3rd Addition, Wichita, Sedgwick County, Kansas; to a beginning point 350.02' North 89°37' West, to a point 15' North 89°37' West, to a point 666.06' North 0°29'58" West, then a 50' radius to a point to the northeast with a 70.8' chord North 44°29'58" East, to a point 300.02' South 89°37' East, to a point 15' South 0°29'58" East, to a point 300.02' North 89°37' West, then a 35' radius to a point to the southwest with a 49.56' chord South 44°29'58" West, to the point of beginning 666.06' South 0°29'58" East.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding one time on 11-18-97, which was at least 20 days prior to the date set for public hearing thereon.

2. No private rights will be injured or endangered by the vacation of the above-described maintenance access easement, and the public will suffer no loss or inconvenience thereby.
