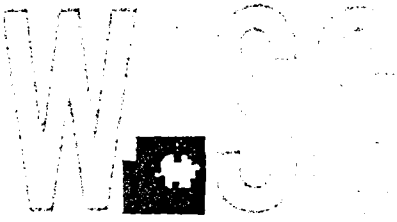

RECOMMENDATION FROM METROPOLITAN AREA PLANNING COMMISSION
TO BOARD OF COUNTY COMMISSIONERS

REQUEST FOR CONDITIONAL USE PERMIT

CU-338 - CONDITIONAL USE PERMIT REQUEST TO ESTABLISH A BASEBALL AND
SOFTBALL COMPLEX ON PROPERTY ZONED "R-1" SUBURBAN RESIDENTIAL
DISTRICT, LOCATED ON THE SOUTH SIDE OF 53RD STREET NORTH,
APPROXIMATELY 1/2 MILE WEST OF HILLSIDE AVENUE.

The MAPC recommends that the application be approved. (see minutes for full motion).

Breckenridge moved, Gramke seconded, and it carried unanimously. Hunt and Parsons were absent.

- ACTION:
1. Adopt the findings of fact of the Metropolitan Area Planning Commission and approve the conditional use permit subject to the recommended conditions including platting; adopt a resolution authorizing the conditional use permit and instruct the Planning Department to withhold publication until the plat has been recorded with the Register of Deeds; or
 2. Adopt findings and deny the application.
