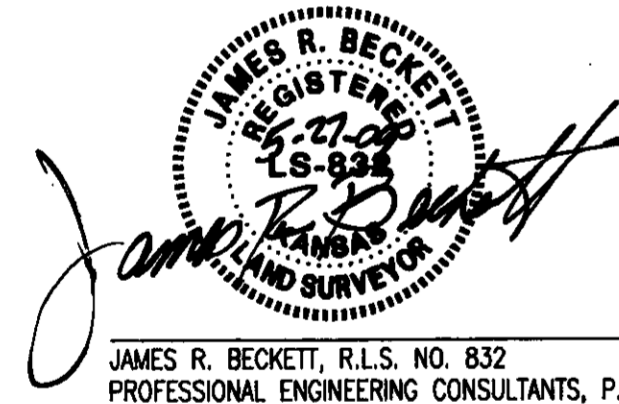

A RE-PLAT OF LOTS 41 THROUGH 68, BLOCK 1; LOTS 1 THROUGH 25, BLOCK 2; LOTS 1 THROUGH 48, BLOCK 3; LOTS 1 THROUGH 19, BLOCK 7; LOTS 1 THROUGH 16, BLOCK 8, AND RESERVES "C", "D", AND "E", AND THE WEST 133.00 FEET OF RESERVE "N", FONTANA, AN ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS;

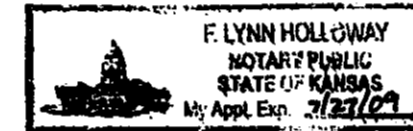

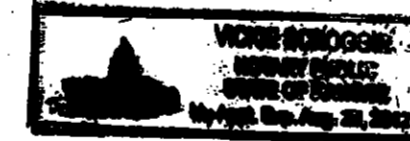
