I, William P. Fox, being a duly licensed Land Surveyor in said County and State, do hereby certify that I have been in responsible charge of surveying and platting ANDALE CO-OP FURLEY ADDITION to Sedgwick County, Kansas, being described as follows:
A tract of land in the Northeast Quarter of Section 16, Township 25 South, Range 2 East of the Sixth Principal Meridian, Sedgwick County, Kansas, more particularly described as follows:
Beginning at the intersection of the West line of the Northeast Quarter of Section 16, Township 25 South, Range 2 East of the Sixth P.M., Sedgwick County, Kansas and the South line of 4th Street as platted in the original town plat of Furley, Sedgwick County, Kansas, thence East along the South line of 4th Street for 300 feet, thence South parallel with the West line of said Northeast Quarter for 150 feet, thence West parallel with the South line of 4th Street to a point on the West line of said Northeast Quarter, thence North along the West line of said Northeast Quarter for 150 feet to the point of beginning,
AND
Beginning at a point on the West line of the Northeast Quarter of Section 16, Township 25 South, Range 2 East of the Sixth P.M., Sedgwick County, Kansas, said point being 150 feet South of the South line of 4th Street as platted in the original town plat of Furley, Sedgwick County, Kansas, thence East parallel with the South line of 4th Street to the West line of the railroad right-of-way line, thence Southwesterly along the railroad right-of-way line to the intersection with the West line of said Northeast Quarter, thence North along the West line of said Northeast Quarter to the point of beginning. Said tract contains 3.126 acres, more or less. The accompanying plat is a true and correct exhibit of property surveyed. Existing public easements are hereby vacated to conform to this plat by virtue of K.S.A. 12-512(b).
