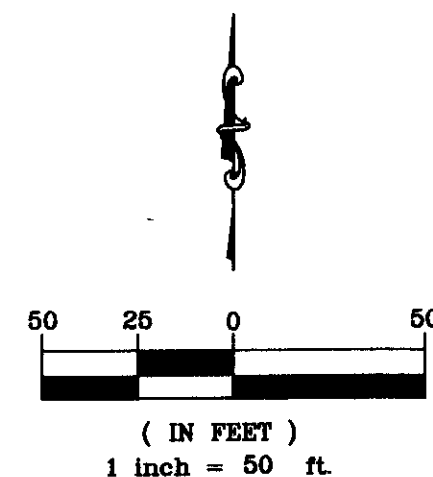

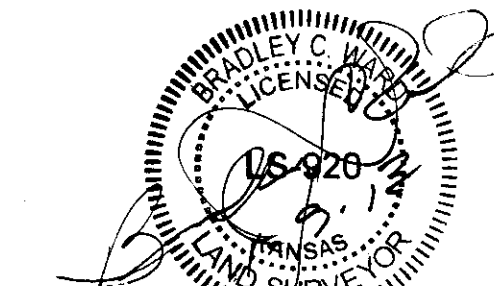

All easements and Rights of Way within said tract are hereby vacated by virtue of KSA 12-512b, as amended.

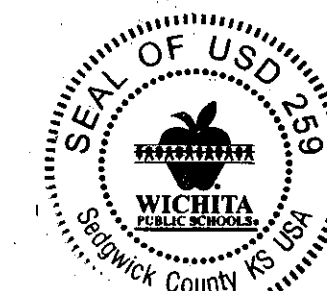

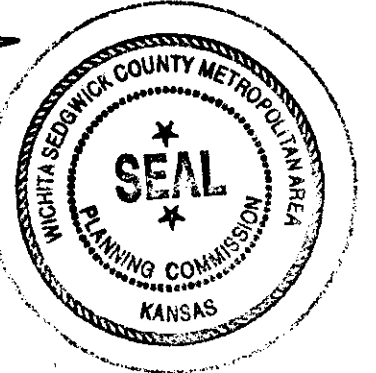
