RE: BZA2016-00014: City Sign Code Adjustment to increase the height of an existing on-site pole sign from 35 to 38 feet, in LC Limited Commercial zoning.

Legal Description: W 100 FT N 122.86 FT M/L LOT 3 & N 122.86 FT M/L LOT 4 RUTH ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS. The property is generally located east of Rock Road on the north side of Kellogg Drive (8300 E. Kellogg Drive.)

Dear Applicants:

We have reviewed your request for a Sign Code Adjustment to increase the height of an existing on-site pole sign by up to 20% in LC zoning. Total square feet of signage is 107 square feet per side.

Section 24.04.221 (3) of the Sign Code limits pole signs in GC and LI zoning to 25 feet in height, which can be increased 5 feet for each unused sign along a street frontage not to exceed 35 total feet in height. Street frontage and number of signs at this location would allow the maximum height of 35 feet. Also, Section 24.04.251.2.b of the Sign Code allows a 20% increase in height by Administrative Adjustment.

We find that allowing the height adjustment of the existing on-site pole sign as proposed meets the three conditions required by Section 24.04.251.6 of the Sign Code as set out below:

- 1) Impact on existing uses in surrounding areas: Existing use in the surrounding area is LC to the east, west and south; and SF-5 Single-Family Residential to the north of the site.
- 2) Compatibility with existing or permitted uses on abutting sites: The height adjustment will be compatible with existing signage in the vicinity.

- 3) Effect on public health, safety or welfare: There will be no encroachment into public right-of-way; there should be no impact on the public health, safety or welfare, nor will properties or improvements in the vicinity be materially injured.

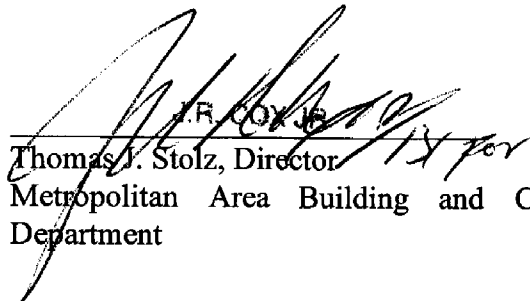
Our signatures below indicate that a Sign Code Adjustment to increase the height of an existing on-site pole sign by up to 20%, from 35 to 38 feet, in LC-Limited Commercial zoning on the aforementioned property is hereby granted, subject to the following conditions:

- 1) The Sign Code Adjustment is for an increase in height from 35 feet to 38 feet only; all signage on the site shall otherwise conform to the Sign Code unless a separate adjustment or variance is approved. No additional signage will be allowed on the site as the maximum permitted signage has been reached.
- 2) The sign shall be in conformance with the approved elevation and site plan. The sign shall be permitted and installed within one year from the date of approval. Portable signs are not allowed on the site.
- 3) If the Zoning Administrator finds that there is a violation of any of the conditions of the Sign Code Adjustment, the Zoning Administrator, in addition to enforcing the other remedies set forth in the Sign Code, may, with the concurrence of the Planning Director, declare that the Sign Code Adjustment is null and void.

The development application sign should now be removed from the property.



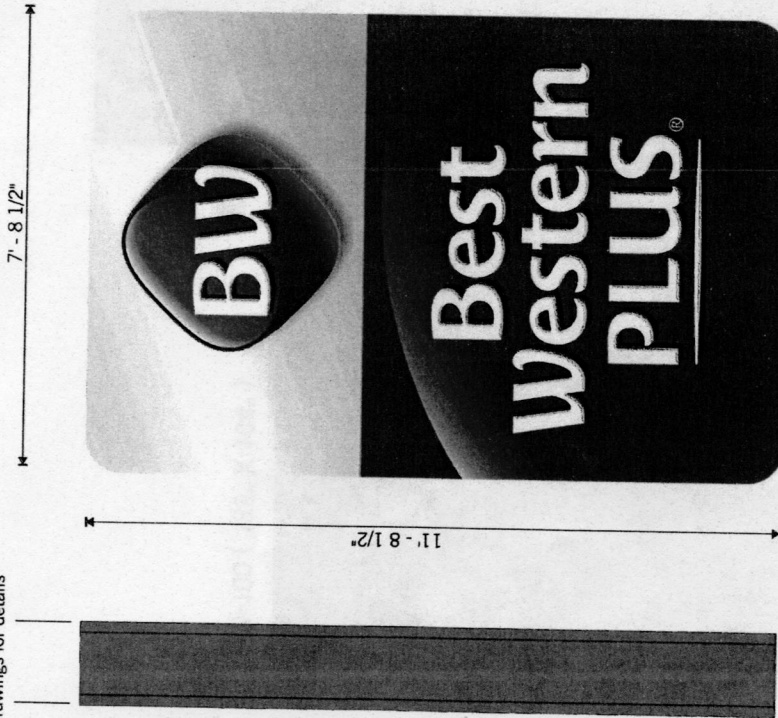
