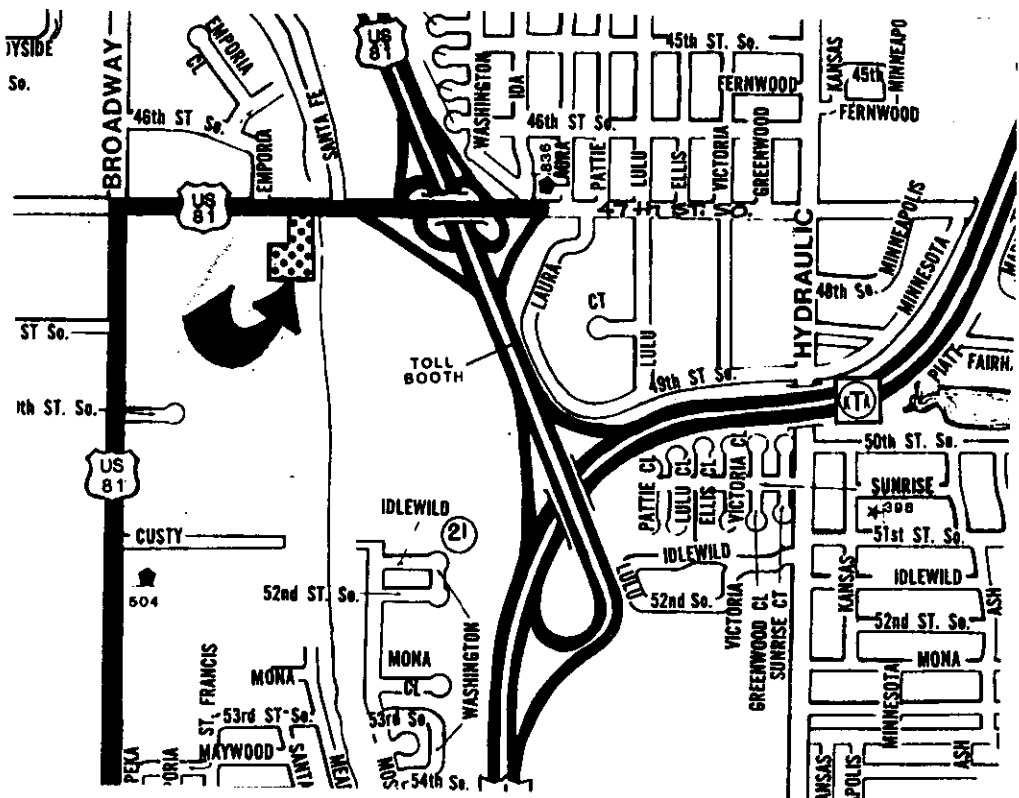

STAFF COMMENTS:

- A. Unless indicated by a revised drainage plan for this site, the applicant shall submit, for recording with the final plat tracing, a cross lot drainage agreement.
- B. The platting of the minimum building pad elevation shall be noted on the face of the plat as well as in the platlor's text. The text shall also note if the minimum elevation involves the lowest opening or floor elevation.
- C. As this property is establishing minimum building pad elevations, the face of the plat shall reference the location and elevation of permanent on-site and off-site benchmarks. Section 5-402(N).
- D. Unless a release can be provided from the pipeline company, the final plat shall indicate the recording information for the 15-foot Derby pipeline easement on this property.
- E. Any relocation, lowering or encasement of the pipeline, made necessary by this development, will not be at the expense of the City.
- F. The final plat tracing shall indicate the appropriate names in printing, of all required signatures by their corresponding signature lines. The applicant is advised that a new MAPC chairman is to be appointed September 14, 1989.
- G. Since this plat is within the City of Wichita, the access control referenced in the platlor's text should be indicated as being "guaranteed to the City of Wichita."
- H. The final plat tracing shall employ an addition name other than the one indicated on the final. Southglenn 2nd Addition would be acceptable. The legal description on the final plat shall also be amended by deleting reference to a Tract B and replacing this with an appropriate description based on the originally platted lot.
- I. In order to redistribute special assessments for this replat, the applicant shall submit, with the final plat tracing, square footage figures for the lots being platted.
- J. The applicant shall install or guarantee the installation of all utilities and facilities which are applicable and described in Article 8 of the MAPC Subdivision Regulations.
- K. The applicant's engineer is advised that the Register of Deeds is requiring the name(s) of the notary public, who acknowledges the signatures on this plat, to be printed beneath the notary's signature.

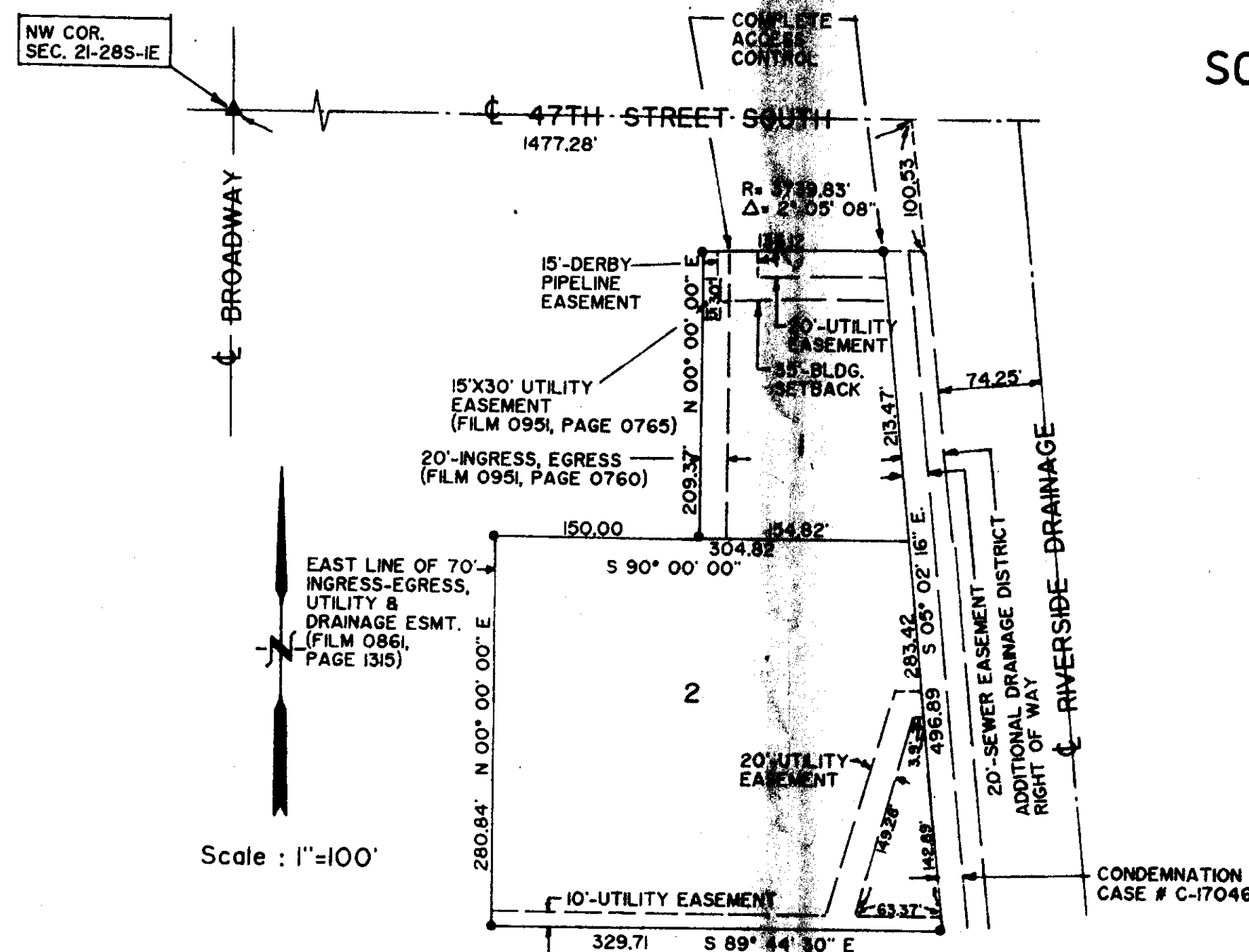
