

BZA RESOLUTION NO. 14-89

WHEREAS, Michael J. Boyd, pursuant to Section 2.12.590.C, Code of the City of Wichita, requests an exception to permit a retail exercise equipment store on property zoned the "OC" Office Commercial District and legally described as follows:

Lot 2, Katherine Boyd Addition to Wichita, Sedgwick County, Kansas. Generally located on the north side of Central between Edgemoor and Old Manor.

WHEREAS, proper notice as required by ordinance and by the rules of the Board of Zoning Appeals has been given; and

WHEREAS, the Board of Zoning Appeals did, at the meeting of April 25, 1989, consider said application; and

WHEREAS, the Board of Zoning Appeals has proper jurisdiction to consider said request for an exception under the provisions of Section 2.12.590.C, Code of the City of Wichita; and

WHEREAS, the Board of Zoning Appeals has authority to permit a retail exercise equipment store on property zoned the "OC" Office Commercial District, subject to the conditions outlined in Section 28.04.085, Code of the City of Wichita.

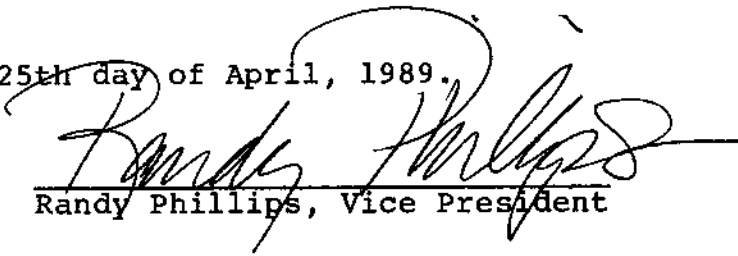

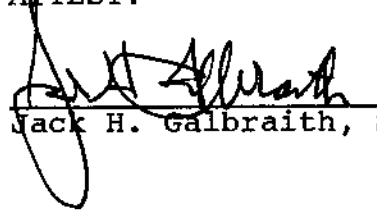
subject to the following conditions:

BACKGROUND: The applicant is requesting a determination that a retail exercise equipment store is a use comparable to the listed uses in the "OC" District and is therefore permitted in that district. A review of the listed retail uses reveals that medical and orthopedic appliance stores are permitted. Staff believes the proposed exercise equipment store is very similar to that use. The 3,000-square-foot size of the proposed store space is well within the 5,000-square-foot maximum floor area allowed for any one use in the "OC" district. The building which will house this use has not yet been constructed. The specific business which wishes to locate on this site is Mid-States Health Products, which is currently in business at 5626 E. Central.

ADJACENT ZONING AND LAND USE:

NORTH	"B" & "AA"	One-family dwellings
SOUTH	"LC"	Restaurants
EAST	"LC"	Stained glass studio and sales
WEST	"OC"	New office and commercial building

RECOMMENDATION: Should the Board determine that a retail exercise equipment store is similar to permitted uses listed in the "OC" District, it is recommended that the exception be approved, subject to the following conditions:

1. The maximum floor area for this exercise equipment store shall not exceed 5,000 square feet.
2. No equipment shall be displayed outside of an enclosed building.
3. Exterior lighting fixtures shall be shaded so that light is directed away from adjacent residential properties.

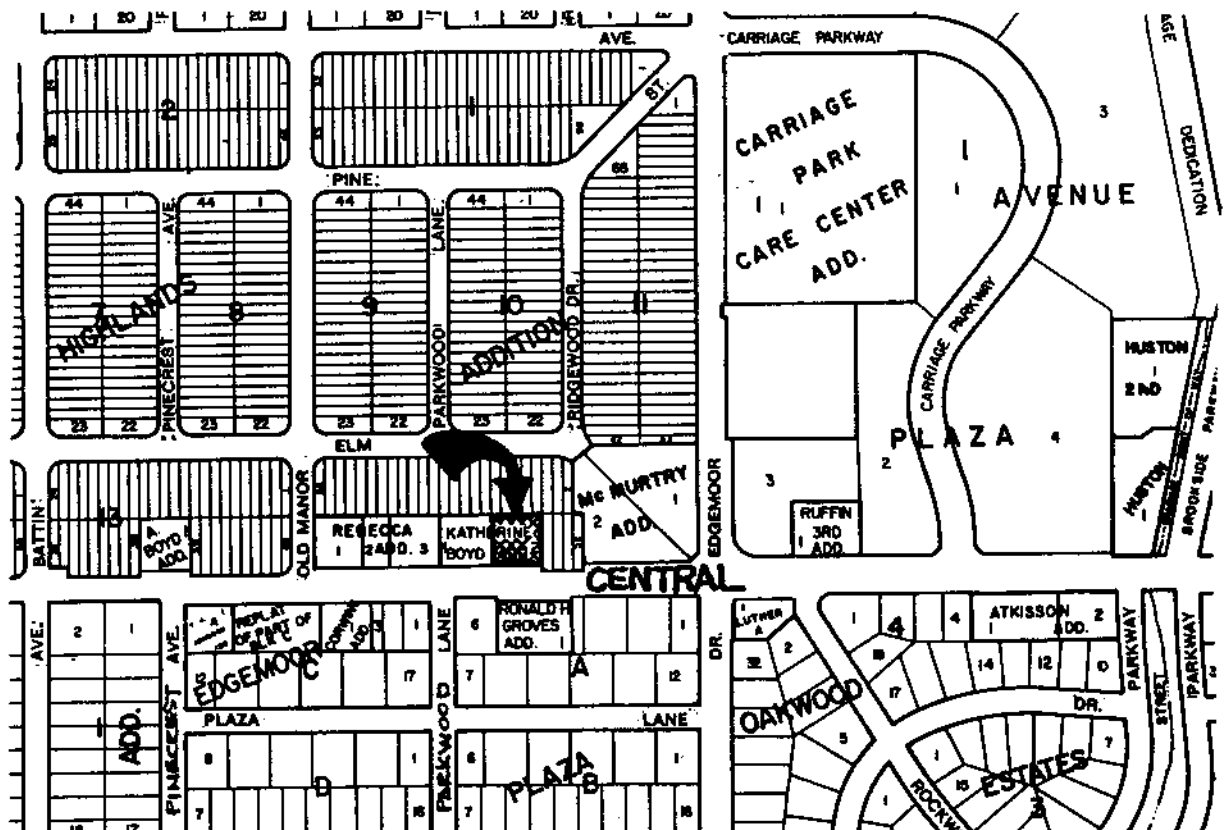
