ORDINANCE NO. 25-132

AN ORDINANCE CREATING A SEWER DISTRICT FOR THE CONSTRUCTION OF A LATERAL SEWER; DEFINING, FIXING AND DETERMINING THE BOUNDARIES OF SAID BENEFIT DISTRICT LIABLE FOR SPECIAL ASSESSMENTS FOR THE COST OF THE CONSTRUCTION OF LATERAL 8, SUBMAIN 5, SANITARY SEWER NO. 22.

WHEREAS, by resolution dated February 21, 1956 the City Engineer of the City of Wichita was directed to prepare a description of the lands properly coming within the sewer district for the construction of a lateral sewer; and,

WHEREAS, the City Engineer pursuant to such instructions filed a description of such lands in the office of the City Clerk of the City of Wichita, on the 19th day of January, 1960;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That there be and is hereby created a sanitary sewer district which shall be known as Lateral 8, Submain 5, Sanitary Sewer No. 22, and that the benefit district liable for special assessments for the cost of construction of such sewer shall be defined, fixed and determined as follows:

All the lots and tracts located between West Street and Florence Street from Douglas Avenue to Second Street.

SECTION 2. That the cost and expense of constructing said Lateral 8, Submain 5, Sanitary Sewer No. 22, shall be chargeable to and paid by the owners of the lots and tracts of land as defined in Section 1 hereof, regardless of assessments of any sewer or sewers heretofore levied thereon and each part, piece and parcel of said lands within said district shall be assessed its proper share and portion of the cost of the construction of said Lateral 8, Submain 5, Sanitary Sewer No. 22, as above provided and shall be certified by the City Clerk to the County Clerk to be placed upon the tax rolls for collection in the same manner as other taxes.

SECTION 3. That pursuant to law negotiable bonds of the City of Wichita shall be issued to pay the cost of construction of said sewer and the amount thereof shall be chargeable to the benefit district as determined herein and assessed against the specified property located therein, in accordance with law.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.

ORDINANCE NO. 25-132

AN ORDINANCE CREATING A SEWER DISTRICT FOR THE CONSTRUCTION OF A LATERAL SEWER; DEFINING, FIXING AND DETERMINING THE BOUNDARIES OF SAID BENEFIT DISTRICT LIABLE FOR SPECIAL ASSESSMENTS FOR THE COST OF THE CONSTRUCTION OF LATERAL 21, SUBMAIN 5, SANITARY SEWER NO. 22.

WHEREAS, by resolution dated September 17, 1957 the City Engineer of the City of Wichita was directed to prepare a description of the lands properly coming within the sewer district for the construction of a lateral sewer; and,

WHEREAS, the City Engineer pursuant to such instructions filed a description of such lands in the office of the City Clerk of the City of Wichita, on the 19th day of January, 1960;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That there be and is hereby created a sanitary sewer district which shall be known as Lateral 21, Submain 5, Sanitary Sewer No. 22, and that the benefit district liable for special assessments for the cost of construction of such sewer shall be defined, fixed and determined as follows:

Lots 1 through 11, inclusive, Nice's Addition.

SECTION 2. That the cost and expense of constructing said Lateral 21, Submain 5, Sanitary Sewer No. 22, shall be chargeable to and paid by the owners of the lots and tracts of land as defined in Section 1 hereof, regardless of assessments of any sewer or sewers heretofore levied thereon and each part, piece and parcel of said lands within said district shall be assessed its proper share and portion of the cost of the construction of said Lateral 21, Submain 5, Sanitary Sewer No. 22, as above provided and shall be certified by the City Clerk to the County Clerk to be placed upon the tax rolls for collection in the same manner as other taxes.

SECTION 3. That pursuant to law negotiable bonds of the City of Wichita shall be issued to pay the cost of construction of said sewer and the amount thereof shall be chargeable to the benefit district as determined herein and assessed against the specified property located therein, in accordance with law.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.
