ORDINANCE NO. 26-023

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN
 BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN
 THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA,
 KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY
 OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Unplatted tracts in the Southeast Quarter of Section 26, Township 27 South, Range 1 West of the 6th P.M. More fully described as follows:

Beginning at a point on the south line of the Southeast Quarter of Section 26 747 feet west of the southeast corner of the Southwest Quarter of said Southeast Quarter, thence north 660 feet; thence east 132 feet; thence south to a point 823.94 feet south of the north line of the Southwest Quarter of said Southeast Quarter; thence east 211.32 feet to the west line of Sabin Avenue; thence south to the south line of said Southeast Quarter; thence west to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, 25-982, 25-983, 25-984, 25-985, 26-001, 26-002, 26-003, 26-004, 26-005, 26-006, 26-007, 26-008, 26-020, 26-921, and 26-022, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-025

AN ORDINANCE AUTHORIZING THE IMPROVEMENT AND REIMPROVEMENT OF CENTRAL AVENUE FROM THE EAST LINE OF RUTAN AVENUE TO THE WEST LINE OF BROADVIEW AVENUE AS A MAJOR TRAFFIC STREET, IN THE CITY OF WICHITA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That it is a public necessity to improve and reimprove Central Avenue from the East line of Rutan Avenue to the West line of Broadview Avenue as follows:
