

ORDINANCE NO. 26-029

AN ORDINANCE VACATING PART OF THE EASEMENT BETWEEN LOTS 3 AND 4, BLOCK 1, WOMER'S THIRD ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the easement described as follows to-wit:

The ten (10) foot easement being five (5) feet on either side of the common line between Lots 3 and 4, Block 1, Womer's Third Addition to Wichita, Sedgwick County, Kansas, lying in the west one hundred fifty two (152) feet of said Lots 3 and 4.

be and the same is herety vacated.

SECTION 2. That it is hereby recommended to the Board of County Commissioners of Sedgwick County, Kansas, that said above described land be vacated by said Board in case a proper petition is filed under the provisions of Sections 12-504, 12-505, and 12-506, of the General Statutes of Kansas, 1949.

SECTION 3. This ordinance shall be in force and take effect from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-030

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Unplatted tract in the Northeast Quarter of Section 35, Township 27 South, Range 1 West of the 6th P.M. more fully described as follows:

Beginning at the northwest corner of the Northeast Quarter of Section 35; thence east to the west line of Schmid Addition; thence south along said west line to the south line of the Northwest Quarter of said Northeast Quarter; thence west to the west line of said Northeast Quarter; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-676, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, 25-982, 25-983,

25-984, 25-985, 26-001, 26-002, 26-003, 26-004, 26-005, 26-006, 26-007, 26-008, 26-020, 26-021, 26-022, and 26-023, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp. 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
