ORDINANCE NO. 26-040

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCK, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Ridgeview 5th Addition in the Southwest Quarter of Section 1, Township 28 South, Range 1 West of the 6th P.M. and West Street, Range 1 West adjacent to Ridgeview 5th Addition more fully described as follows:

Beginning at the intersection of the north line of 31st Street South and the west line of West Street; thence north along said west line to the north line of Ridgeview 5th Addition extending from the east; thence east along said north line to the east line of said Addition; thence southerly along said east line to the north line of 31st Street South; thence west to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, 25-987, 25-988, 25-984, 25-985, 26-001, 26-002, 26-003, 26-004, 26-005, 26-006, 26-007, 26-008, 26-020, 26-021, 26-022, 26-023, 26-030, 26-031, 26-032, 26-033, 26-037, 26-038, 26-039, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 17-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
