ORDINANCE NO. 26-107

AN ORDINANCE PROMULGING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Southwest Quarter of Section 36, Township 26 South, Range 1 East of the 6th P.M. more fully described as follows:

Beginning at a point on the east line of Oliver one thousand three hundred and four (1304) feet north of the south line of said Southwest Quarter; thence east to the east line of the west one-half of said Southwest Quarter; thence south to the south line of said Southwest Quarter; thence west to the east line of Oliver; thence north to the point of beginning.

SECTION 2. ORDINANCE NO. 26-108

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northeast Quarter of Section 28, Township 27 South, Range 2 East of the 6th P.M. and adjacent to U.S. 54 Highway right-of-way and adjacent to Kansas Turnpike right-of-way more fully described as follows:

Beginning at the point of intersection of the west line of said Northeast Quarter extended from the south and the north line of U.S. 54 Highway; thence east along the north line of U.S. 54 Highway to the east line of the Northwest Quarter of said Northeast Quarter extended from the south; thence south to the south line of the Kansas Turnpike; thence west along said south line to the west line of said Northeast Quarter; thence north to point of beginning.

SECTION 2.
