

ORDINANCE NO. 26-149

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN
BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN
THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA,
KANSAS AND RELATING THERE TO

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY
OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land
be and they are hereby included and brought within the corporate limits of the City
of Wichita, Kansas:

Unplatted tracts in the southwest Quarter of Section 32, Township 26
South, Range 1 east of the 6th P.M. more fully described as follows:

Beginning at the northwest corner of the east one-half of the south
ten (10) acres of the west one-half of the southwest Quarter of said
southwest quarter; thence east to the west line of Salina; thence
south to the north line of 26th Street; thence west to the west line
of the east one-half of the south ten (10) acres of the west one-
half of the southwest Quarter of said southwest Quarter; thence north
to point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp. 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
