

ORDINANCE NO. 26-152

AN ORDINANCE INCORPORATING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A. Unplatted tracts in the Southeast Quarter of Section 34, Township 26 South, Range 1 East of the 6th P.M. and adjacent street right-of-way more fully described as follows:

Beginning at the northwest corner of the northeast quarter of the Southeast Quarter of Section 34; thence north to the southwest corner of the northeast quarter of said Southeast Quarter; thence east along the south line of the northeast quarter of said Southeast Quarter and said south line extended, to the east line of Hillside Avenue; thence north along said east line to the north line of said Southeast Quarter extended from the west, thence west to the point of beginning.

SECTION 2. SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
