SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

ORDINANCE NO. 26-197

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Country Acres 2nd Addition, in Section 16, Township 27, South, Range 1, West of the 6th P.M., more fully described as follows:

Beginning at the southeast corner of said Section 16; thence north along the east line of said Section 16 to the north line of the south half of the Northeast Quarter of said Section 16; thence west to the northwest corner of the south half of said Northeast Quarter; thence south to the northeast corner of the Southwest Quarter of said Section 16; thence west along the north line of said Southwest Quarter to a point two hundred forty-eight (248) feet east of the west line of said Southwest Quarter; thence south along a line parallel to and two hundred forty-eight (248) feet east of the west line of said Southwest Quarter to the south line of the north half of said Southwest Quarter; Thence east along said south line to the northerly line of School Street; thence northeasterly along said line to the easterly line of

ORDINANCE NO. 26-198

AN ORDINANCE ADOPTING A NEW REVISION AND CODIFICATION OF ORDINANCES OF THE CITY OF WICHITA, KANSAS; PROVIDING SPECIFICALLY FOR THE REPEAL OF ORDINANCE NO. 25-681; PROVIDING GENERALLY FOR THE REPEAL OF CERTAIN OTHER ORDINANCES OF THE CITY NOT INCLUDED HEREIN; EXCEPTING CERTAIN GENERAL AND SPECIAL ORDINANCES OF THE CITY FROM REPEAL; SAVING CERTAIN RIGHTS, DUTIES, FORFEITURES AND PENALTIES; AND PROVIDING RULES FOR THE CONSTRUCTION THEREOF.
