ORDINANCE NO. 26-246

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

H. J. Born Addition, in the north half of Section 32, Township 26, South, Range 1, East of the 6th P.M., more fully described as follows:

Beginning at a point on the west line of the Northeast Quarter of Section 32 two hundred nine and sixty-four hundredths (209.64) feet south of the northwest corner of said Northeast Quarter; thence southeasterly with an interior angle of seventy-seven (77) degrees nine (9) minutes a distance of four hundred thirty-six and twenty-five hundredths (436.25) feet more or less, to a point four hundred twenty-five and fourteen hundredths (425.14) feet east of the west line of said Northeast Quarter; thence south parallel to said west line a distance of seventy-eight and eighty-four hundredths (78.84) feet more or less; thence west a distance of four hundred twenty-five and fourteen hundredths (425.14) feet to a point on said west line two hundred ninety-three and fifteen hundredths (293.15) feet north of the southwest corner of the north half of the Northwest Quarter of said Northeast Quarter; thence north to a point three hundred two (302) feet north of the southeast corner of the north half of the Northeast Quarter of the Northwest Quarter of said Section 32; thence west parallel to the south line of said north half a distance of six hundred sixty (660) feet more or less, to the west line of the north half of the Northeast Quarter of said Northwest Quarter; thence north along said west line to the south line of 37th Street; thence southeasterly along said south line to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-163, 26-169, 26-170, 26-171, 26-186, 26-187, 26-188, 26-189, 26-190, 26-195, 26-196, 26-197, 26-228, 26-229, 26-230, 26-233, 26-234, 26-235, 26-236, 26-237, 26-238, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or

lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-247

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Southeast Quarter of Section 21, Township 27, South, Range 2 East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the north right-of-way line of U. S. Highway 54 (Kellogg) and the east line of the Southeast Quarter of Section 21; thence north along said east line to a point two hundred ninety-six and three-tenths (296.3) feet north of the south line of said Southeast Quarter; thence west parallel to said south line a distance of two hundred fifty (250) feet; thence south parallel to the east line of said Southeast Quarter to the north line of said Highway; thence east to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-163, 26-169, 26-170, 26-171, 26-186, 26-187, 26-188, 26-189, 26-190, 26-195, 26-196, 26-197, 26-228, 26-229, 26-230, 26-233, 26-234, 26-235, 26-236, 26-237, 26-238, 26-246, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.
