ORDINANCE NO. 26-259

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Southwest Quarter of Section 16, Township 27, South, Range 1, West of the 6th P.M., more fully described as follows:

Beginning at the northwest corner of the south half of the Southwest Quarter of Section 16; thence east along the north line of said south half a distance of nine hundred eighty-four and four-tenths (984.4) feet; thence south at a right angle a distance of one hundred fourteen (114) feet to the point of curvature of a curve to the right having a central angle of eighteen (18) degrees forty-six (46) minutes and a radius of seven hundred twenty-one and seventy-eight hundredths (721.78) feet; thence along said curve two hundred thirty-six and four-tenths (236.4) feet to the point of tangent of said curve; thence continuing on tangent to said curve one hundred sixty (160) feet; thence with an angle to the right of ninety (90) degrees a distance of one hundred thirty-seven (137) feet, more or less, to the intersection of a line four hundred fifty (450) feet south of and parallel to the north line of said south half; thence west along said line a distance of seven hundred seventy-five (775) feet, more or less, to the west line of said south half; thence north to the point of beginning.

SECTION 2. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.
