#### ORDINANCE NO. 26-310

AN ORDINANCE INCORPORATING AND RECONFIGURATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THEREC.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Southeast Quarter of Section 28, Township 27, South, Range 1, West of the 6th P.M., more fully described as follows:

Beginning at the intersection of the west line of the Southeast Quarter of Section 28 and the north right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence north along said west line to a point four hundred seventy-nine (479) feet south of the northwest corner of said Southeast Quarter; thence east parallel to the north line of said Southeast Quarter a distance of four hundred nineteen and five-tenths (419.5) feet; thence north parallel to the west line of said Southeast Quarter a distance of one hundred (100) feet; thence east parallel to and three hundred seventy-nine (379) feet south of the north line of said Southeast Quarter to the west line of the east half of said Southeast Quarter; thence north to a point three hundred sixty-nine and two-tenths (369.2) feet south of the northwest corner of said east half; thence easterly parallel to the south line of U.S. Highway 54 a distance of three hundred (300) feet; thence north parallel to the west line of said east half a distance of two hundred (200) feet to the south line of said Highway; thence easterly along said south line a distance of one hundred ninety-nine and two-tenths (199.2) feet, more or less, to a point eight hundred twenty (820) feet west of the east line of said Southeast Quarter; thence south parallel to the east line of said Southeast Quarter a distance of two hundred (200) feet; thence easterly parallel to the south line of said Highway a distance of five hundred ninety (590) feet; thence north one and seven-tenths (1.7) feet; thence easterly two hundred thirty (230) feet to a point on the east line of said Southeast Quarter which is three hundred fifty-nine and four-tenths (359.4) feet south of the northeast corner of said Southeast Quarter; thence south along said east line to the north line of the Atchison, Topeka and Santa Fe Railroad; thence westerly along said north line to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-163, 26-169, 26-170, 26-171, 26-186, 26-187, 26-188, 26-189, 26-190, 26-195, 26-196, 26-197, 26-228, 26-229, 26-230, 26-233, 26-234, 26-235, 26-236, 26-237, 26-238, 26-246, 26-247, 26-248, 26-249, 26-250, 26-255, 26-256, 26-257, 26-258, 26-259, 26-260, 26-265, 26-266, 26-267, 26-268, 26-269, 26-271, 26-282, 26-283, 26-284, 26-285, 26-286, 26-310, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

#### ORDINANCE NO. 26-312

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Southeast Quarter of Section 21, Township 27, South, Range 1, West of the 6th P.M., more fully described as follows:

Beginning at the northwest corner of the east half of the west half of the Southeast Quarter of Section 21; thence south along the west line of said east half to a point three hundred forty (340) feet north of the southwest corner of said east half; thence east seventy-five (75) feet; thence north parallel to the west line of said east half a distance of nine hundred seventy-eight and ninety-seven hundredths (978.97) feet to the south line of the north ten (10) acres of the west half of the east half of the west half of said Southeast Quarter; thence east to the southeast corner of said north ten (10) acres; thence north to the northeast corner of said north ten (10) acres; thence west to the point of beginning.
