

## ORDINANCE NO. 26-411

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Northeast Quarter of Section 32, Township 26, South, Range 1, East of the 6th P.M., more fully described as follows:

Beginning at a point on the south line of 37th Street and five hundred forty-two and sixty-four hundredths (542.64) feet west of the west line of Broadway Avenue; thence east along said south line a distance of two hundred sixty-six and five-tenths (266.5) feet; thence south seven hundred and three-tenths (700.3) feet; thence east two hundred seventy-six and fourteen hundredths (276.14) feet to the west line of Broadway Avenue; thence east to the east right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence south along said east right-of-way line a distance of one hundred fifty (150) feet; thence west to a point on the west line of Broadway Avenue eight hundred fifty and three-tenths (850.3) feet south of the south line of 37th Street; thence west two hundred seventy-six and fourteen hundredths (276.14) feet to a point eight hundred fifty (850) feet south of the south line of 37th Street; thence west two hundred sixty-six and five-tenths (266.5) feet; thence north eight hundred fifty (850) feet to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-163, 26-169, 26-170, 26-171, 26-186, 26-187, 26-188, 26-189, 26-190, 26-195, 26-196, 26-197, 26-228, 26-229, 26-230, 26-233, 26-234, 26-235, 26-236, 26-237, 26-238, 26-246, 26-247, 26-248, 26-249, 26-250, 26-255, 26-256, 26-257, 26-258, 26-259, 26-260, 26-265, 26-266, 26-267, 26-268, 26-269, 26-271, 26-282, 26-283, 26-284, 26-285, 26-286, 26-310, 26-311, 26-312, 26-313, 26-347, 26-348, 26-349, 26-392, 26-393, 26-394, 26-395, 26-399, 26-400, 26-401, 26-402, 26-403, 26-404, 26-405, 26-406, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
