That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance No. 26-918 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp. 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-920

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Lot 15, Suburban Acres, and 41st Street right-of-way, in the Northeast Quarter of Section 29, Township 26 South, Range 1 East of the 6th P. M., more fully described as follows:

Beginning at a point on the west line of the Northeast Quarter of Section 29 two hundred twenty and eight-tenths (220.8) feet north of the southwest corner of said Northeast Quarter; thence east parallel to the south line of said Northeast Quarter a distance of one thousand ninety (1090) feet; thence south parallel to the west line of said Northeast Quarter a distance of two hundred twenty and eight-tenths (220.8) feet to the south line of said Northeast Quarter; thence

east along said south line a distance of one hundred (100) feet; thence north parallel to the west line of said Northeast Quarter a distance of two hundred eighty and eight-tenths (280.8) feet; thence west parallel to the south line of said Northeast Quarter a distance of one thousand one hundred ninety (1190) feet to the west line of said Northeast Quarter; thence south a distance of sixty (60) feet to the point of beginning.

ORDINANCE NO. 26-921

AN ORDINANCE PROVIDING FOR THE ISSUANCE OF PERMITS AND THE REGULATION OF PERSONS ENGAGED COMMERCIALY IN THE CONTROL OF PLANT, INSECT, ARACHNID, RODENT OR OTHER PESTS; REQUIRING THAT ALL PERSONS AND EMPLOYEES OF PERSONS ENGAGED COMMERCIALY IN PEST CONTROL BE REGISTERED; PROVIDING FOR THE VOLUNTARY EXAMINATION AND ISSUANCE OF PERMITS FOR EMPLOYEES AND OTHER PERSONS AS CERTIFIED PEST CONTROL OPERATORS; AMENDING SECTIONS 3.76.010; 3.76.020; 3.76.030; 3.76.040; 3.76.050; 3.76.060; 3.76.070; 3.76.080; 3.76.090; 3.76.100; 3.76.110; 3.76.120; AND 3.76.140 OF THE CODE OF THE CITY OF WICHITA, KANSAS; AND REPEALING SAID ORIGINAL SECTIONS AND SECTION 3.76.130 OF SAID CODE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION I. That Section 3.76.010 of the Code of the City of Wichita, Kansas, be and the same is amended to read as follows:

SECTION I - Definitions. CITY CLERK shall mean the lawfully appointed clerk of the City of Wichita, Kansas.
LICENSE COLLECTOR shall mean the person officially designated as the license collector of the City of Wichita, Kansas.
