

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-926

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING HERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

F. A. Brown Fourth Addition in the Northwest Quarter of Section 22, Township 28 South, Range 1 East of the 6th P. M., more fully described as follows:

Beginning at a point on the west line of the Northwest Quarter of Section 22 eight hundred eleven and twenty-six hundredths (811.26) feet north of the southwest corner of said Northwest Quarter; thence east along the north line of 50th Street South a distance of three hundred fifty-four and forty-seven hundredths (354.47) feet; thence north a distance of one hundred twenty (120) feet; thence east parallel to the north line of 50th Street South a distance of one thousand five hundred twenty-nine and thirty-two hundredths (1529.32) feet to the westerly right-of-way of the Riverside Levee; thence southerly along said right-of-way line to the south line of said Northwest Quarter; thence west along said south line to a point nine hundred fifty-two and thirteen hundredths (952.13) feet east of the southwest corner of said Northwest Quarter; thence right at ninety (90) degrees a distance of four hundred eighty-six and twenty-six hundredths (486.26) feet; thence left at ninety (90) degrees a distance of six hundred fifty-seven and seven hundredths (657.07) feet;

Unplatted tract in the Northwest Quarter of Section 20, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the southwest corner of the north half of the Northwest Quarter of Section 20; thence east along the south line of the north half of said Northwest Quarter to the west right-of-way line of the Midland Valley Railroad; thence northerly along said right-of-way line to the north line of the south half of the north half of said Northwest Quarter; thence west along said north line to a point one thousand two hundred seventy-four and five-tenths (1274.5) feet east of the west line of said Northwest Quarter; thence south parallel to said west line to a point three hundred thirty (330) feet north of the south line of the north half of said Northwest Quarter; thence
