

ORDINANCE NO. 26-929

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Lots 10, 11, 12, 13, and the north half of Lot 14, Westfield Acres, in the Southeast Quarter of Section 20, Township 27 South, Range 1 West of the 6th P. M., more fully described as follows:

Beginning at a point on the south line of the Southeast Quarter of Section 20 one thousand one hundred seventy-nine (1179) feet west of the southeast corner of said Southeast Quarter; thence north parallel to the east line of said Southeast Quarter a distance of four hundred five (405) feet; thence west parallel to the south line of said Southeast Quarter a distance of six hundred four and fifteen hundredths (604.15) feet, more or less, to a point one hundred ninety-five (195) feet east of the west line of the east half of the west half of said Southeast Quarter; thence south parallel to said west line a distance of one hundred eighty-seven and five-tenths (187.5) feet; thence east parallel to the south line of said Southeast Quarter to a point one thousand six hundred sixty-three (1663) feet west of the east line of said Southeast Quarter; thence south parallel to said east line a distance of two hundred seventeen and five-tenths (217.5) feet to the south line of said Southeast Quarter; thence east a distance of four hundred eighty-four (484) feet to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

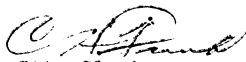
