ORDINANCE NO. 26-937

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Mona Kay Matlock Addition, in the Southwest Quarter of Section 22, Township 28 South, Range 1 East of the 6th P. M. more fully described as follows:

Beginning at a point on the north line of the Southwest Quarter of Section 22 three hundred twenty-five and eighty-six hundredths (325.86) feet east of the northwest corner of said Southwest Quarter; thence east along the north line of said Southwest Quarter to the west right-of-way line of the Wichita-Valley Center Riverside Levee; thence right at an angle of seventy-nine (79) degrees thirty-five (35) minutes along said right-of-way a distance of eighty and thirty-eight hundredths (80.38) feet; thence left at an angle of three (3) degrees fifty-two (52) minutes a distance of one thousand seventy-six and sixty-seven hundredths (1076.67) feet; thence left at an angle of two (2) degrees two (02) minutes a distance of three hundred thirty-three and ninety-one hundredths (333.91) feet; thence right at an angle of one hundred six (106) degrees twenty (20) minutes a distance of two thousand one hundred eighty-six and twenty-two hundredths (2186.22) feet; thence right at an angle of eighty-nine (89) degrees fifty-one (51) minutes a distance of one hundred twenty-five (125) feet; thence left at an angle of eighty-nine (89) degrees fifty-one (51) minutes a distance of one hundred seventy-five (175) feet to a point on the west line of said Southwest Quarter one thousand three hundred thirty and eighty-two hundredths (1330.82) feet north of the southwest corner of said Southwest Quarter; thence north along said west line a distance of four hundred twenty-five (425) feet; thence right at an angle of ninety (90) degrees nine (9) minutes a distance of two hundred ninety and six hundredths (290.06) feet; thence left at an angle of ninety (90) degrees nine (09) minutes a distance of one hundred fifty (150) feet; thence left at an angle of eighty-nine (89) degrees fifty-one (51) minutes a distance of two hundred ninety-one and thirty-five hundredths (291.35) feet to the west line of said Southwest Quarter; thence north along said west line a distance of eighty-two and forty-seven hundredths (82.47) feet; thence right at an angle of ninety (90) degrees fourteen (14)

minutes a distance of one thousand three hundred twenty (1320) feet; thence left at an angle of ninety (90) degrees fourteen (14) minutes a distance of three hundred thirty (330) feet; thence left at an angle of eighty-nine (89) degrees forty-six (46) minutes a distance of one thousand three hundred twenty (1320) feet to the west line of said Southwest Quarter; thence north along said west line a distance of one hundred sixty-three (163) feet; thence right at an angle of ninety (90) degrees fourteen (14) minutes a distance of two hundred ninety-three and one-tenth (293.1) feet; thence left at an angle of ninety (90) degrees fourteen (14) minutes a distance of eighty-six and fifteen hundredths (86.15) feet to the point of curvature of a curve to the right having a delta of forty-five (45) degrees zero (00) minutes thirty (30) seconds and a radius of one hundred ten (110) feet; thence along said curve a distance of eighty-six and four-tenths (86.4) feet, more or less, to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to cause an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-938

AN ORDINANCE AUTHORIZING THE REVISION AND RECODIFICATION OF THE CODE OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the revision and recodification of the Code of the City of Wichita, Kansas, pursuant to and in conformity with Sections 12-3014 and 12-3015 of the 1961 Supplement to the General Statutes of Kansas, 1949, be and the same is hereby authorized.
