

Beginning at a point on the east right-of-way line of the Atchison, Topeka and Santa Fe Railroad thirty-five (35) feet north of the south line of the Southwest Quarter of Section 26; thence east parallel to said south line to the east right-of-way line of the St. Louis-San Francisco Railroad; thence north along said right-of-way line to the southerly right-of-way line of the Chisholm Creek Diversion; thence southwesterly along said right-of-way line to the east right-of-way line of the Atchison, Topeka and Santa Fe Railroad, thence south to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 16-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, 26-944, 26-945, 26-950, 26-951, 26-952, 26-953, 26-954, 26-955, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-919

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Westlink Heights, in the Southeast Quarter of Section 20, Township 27 South, Range 1 West of the 1st P.M., more fully described as follows:

Beginning at a point on the north line of the Southeast Quarter of Section 20 one hundred sixty-eight (168) feet east of the southwest corner of said Southeast Quarter; thence north parallel to the west line of said Southeast Quarter a distance of one thousand one hundred fifty (1150) feet to the point of curvature of a curve to the

right having a radius of two hundred and seven-tenths (200.7) feet; thence along said curve to a point three hundred sixty-seven and eighty-three hundredths (367.83) feet east of the west line of said Southeast Quarter; thence east parallel to the south line of said Southeast Quarter a distance of three hundred ninety-six and twenty-one hundredths (396.21) feet to a point twenty-nine and eighty-three hundredths (29.83) feet west of the west line of Westfield Avenue; thence northeasterly along a curve to the left having a radius of thirty (30) feet to the west line of Westfield Avenue; thence south along said west line a distance of one thousand three hundred seventy-nine and eighty-three hundredths (1379.83) feet to the south line of said Southeast Quarter; thence west a distance of six hundred twenty-six and ninety-eight hundredths (626.98) feet to the point of beginning.
