

Unplatted tract in the Northeast Quarter of Section 29, Township 26 South, Range 1 East of the 6th P. M., more fully described as follows:

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-962

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Block C, Edwards Gardens, and adjacent street right-of-way, in the Northwest Quarter of Section 29, Township 26 South, Range 1 East of the 6th P. M., more fully described as follows:

Beginning at a point on the east line of the Northwest Quarter of

Section 29 one hundred one and forty-six hundredths (101.46) feet south of the northeast corner of the southeast quarter of said Northwest Quarter; thence south along said east line a distance of two hundred seventy-five (275) feet; thence right at an angle of ninety (90) degrees a distance of one thousand thirty-three and eight-tenths (1033.8) feet; thence right at an angle of eighty-five (85) degrees thirty-one (31) minutes thirty (30) seconds a distance of seven hundred thirty-seven and six-tenths (737.6) feet; thence left at an angle of seventy-eight (78) degrees thirty-seven (37) minutes thirty (30) seconds a distance of thirty-six (36) feet; thence right at an angle of ninety-four (94) degrees thirty (30) minutes a distance of two hundred twenty-eight (228) feet; thence right at an angle of twenty (20) degrees forty-five (45) minutes a distance of eighty-seven and ninety-eight hundredths (87.98) feet to a point on the south line of the north twelve and sixty-five hundredths (12.65) acres of Government Lot 5 in said Northwest Quarter; thence east along said south line a distance of two hundred forty-two and twenty-eight hundredths (242.28) feet to the east line of Mascot Avenue; thence south along said east line a distance of seven hundred ten (710) feet to the point of curvature of a curve to the left having a radius of fifty (50) feet; thence along said curve a distance of seventy-seven and five-tenths (77.5) feet, more or less, to the point of tangent of said curve; thence east along the north line of 43rd Street to the point of beginning.
