That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-994

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the west half of Section 29, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at a point on the east line of the Northwest Quarter of Section 29 three hundred seventy-six and forty-six hundredths (376.46) feet south of the northeast corner of the southeast quarter of said Northwest Quarter; thence west at ninety (90) degrees to the east line of said Northwest Quarter a distance of one thousand thirty-three and eight-tenths (1033.8) feet; thence right at an angle of eighty-five (85) degrees thirty-one (31) minutes, thirty (30) seconds a distance of seven hundred thirty-seven and six-tenths (737.6) feet; thence left at an angle of seventy-eight (78) degrees thirty-seven (37)

minutes thirty (30) seconds a distance of thirty-six (36) feet to the easterly right-of-way line of the Big Ditch Chisholm Creek Diversion; thence southerly and southeasterly along said right-of-way line to the east line of said Section 29; thence north to the point of beginning.

ORDINANCE NO. 26-995

AN ORDINANCE APPROPRIATING AND ASSESSING THE COST OF EXCAVATING, CONSTRUCTING CURB AND GUTTER, AND PAVING EAST HALF OF ARMOUR LAND FROM THE NORTH LINE OF 13TH STREET TO THE NORTH LINE OF LOT 7, BLOCK 2, MC EWEN 8TH ADDITION IN THE CITY OF WICHITA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the cost of excavating, constructing curb and gutter, and paving East Half of Armour Lane from the North Line of 13th Street to the North Line of Lot 7, Block 2, McEwen 8th Addition in the City of Wichita, Kansas, which is chargeable to private property owners has been ascertained to be \$18,184.23, and the payment of each lot, piece and parcel of land liable for the cost of said improvement has been equalized on all its pieces and parcels of land to the center of the block on east side of the said street for the distance to be paved, in the proportion hereinafter set out, now

THEREFORE there is hereby appropriated and assessed to pay the cost of said improvement, the following taxes due on the following described lots, pieces and parcels of land liable therefor in said paving district.
