ORDINANCE NO. 27-011

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Northeast Quarter of Section 21, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the east line of the Northeast Quarter of Section 21 and the north line of the south five (5) acres of the east half of said Northeast Quarter; thence west along said north line to the west line of said east half; thence north along said west line to a point six hundred forty-seven (647) feet south of the north line of said Northeast Quarter; thence southeasterly to a point on the east line of said Northeast Quarter eight hundred sixty-one (861) feet north of the northeast corner of said Northeast Quarter; thence south to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, 26-944, 26-945, 26-950, 26-951, 26-952, 26-953, 26-954, 26-955, 26-958, 26-959, 26-960, 26-961, 26-962, 26-973, 26-974, 26-975, 26-976, 26-992, 26-993, 26-994, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or amend any other provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby authorized at the proper time to draw an ordinance reader about the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-11, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 27-012

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Southeast Quarter of Section 21, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the northeast corner of the Southeast Quarter of Section 21; thence south along the east line of said Southeast Quarter to a point four hundred eighty-eight and eight-tenths (488.8) feet north of the south line of the north half of the north half of said Southeast Quarter; thence west a distance of two hundred eight and seven-tenths (208.7) feet; thence south a distance of one hundred seventy-nine and four-tenths (179.4) feet; thence west a distance of two hundred eight and seven-tenths (208.7) feet; thence south a distance of one hundred four and four-tenths (104.4) feet; thence west a distance of seven and six-tenths (7.6) feet; thence south a distance of two hundred five (205) feet to a point on the south line of the north half of the north half of said Southeast Quarter four hundred twenty-five (425) feet west of the east line of said Southeast Quarter; thence west along said south line to the east right-of-way line of the Kansas Turnpike; thence northerly along said right-of-way line to the north line of said Southeast Quarter; thence east to the point of beginning.

SECTION 2. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.
