ORDINANCE NO. 27-015

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

37th Street Right-of-way in the Southeast Quarter of Section 30, Township 26 South, Range 1 East of the 6th P. M., more fully described as follows:

Beginning at the southwest corner of the Southeast Quarter of Section 30; thence east along the south line of said Southeast Quarter to the northerly right-of-way line of the Main Branch of Christholm Creek Diversion; thence northeasterly along said right-of-way line to the east line of said Southeast Quarter; thence north along said east line to the north right-of-way line of 37th Street; thence southwesterly and west along said right-of-way line to the west line of said Southeast Quarter; thence south to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, 26-944, 26-945, 26-950, 26-951, 26-952, 26-953, 26-954, 26-955, 26-958, 26-959, 26-960, 26-961, 26-962, 26-973, 26-974, 26-975, 26-976, 26-992, 26-993, 26-994, 27-011, 27-012, 27-013, 27-014, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 17-217 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 27-016

AN ORDINANCE APPORTIONING AND ASSESSING THE COST OF EXCAVATING, CONSTRUCTING CURB, AND PAVING COLORADO STREET FROM THE SOUTH LINE OF DOUGLAS AVENUE TO THE NORTH LINE OF MAPLE STREET IN THE CITY OF WICHITA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the cost of excavating, constructing curb, and paving Colorado Street from the South Line of Douglas Avenue to the North Line of Maple Street in the City of Wichita, Kansas, which is chargeable to private property owners has been ascertained to be \$23,481.75, and the payment of each lot, piece and parcel of land liable for the cost of said improvement has been equalized on all lots, pieces and parcels of land to the center of the block on either side of the said street, for the distance to be paved, in the proportion hereinafter set out, now

THEREFORE there is hereby apportioned and assessed to pay the cost of said improvement, the following named sums on the following described lots, pieces and parcels of land liable therefor in said paving district.

A copy of which appraisalment, with words and figures is hereto attached and marked Exhibit "A" and made a part hereof, the same being the report of the appraisers, appointed thereon, and with the names of the owners of the described property erased, and said report having been approved by the Board of Commissioners on February 26, 1963.
