ORDINANCE NO. 27-200

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northeast Quarter of Section 29, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at a point on the west line of the Northeast Quarter of Section 29 one thousand eight hundred sixty-two and sixty-four hundredths (1862.64) feet north of the southwest corner of said Northeast Quarter; thence east parallel to the south line of said Northeast Quarter a distance of seven hundred twenty-six (726) feet; thence south parallel to the west line of said Northeast Quarter a distance of two hundred forty (240) feet; thence east parallel to the south line of said Northeast Quarter to the westerly right-of-way line of the Chisholm Creek Diversion; thence northerly along said right-of-way line to the south right-of-way line of the Kansas Gas and Electric spur track; thence west along said right-of-way line to the west line of said Northeast Quarter; thence south to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, 26-944, 26-945, 26-950, 26-951, 26-952, 26-953, 26-954, 26-955, 26-958, 26-959, 26-960, 26-961, 26-962, 26-973, 26-974, 26-975, 26-976, 26-992, 26-993, 26-994, 27-011, 27-012, 27-013, 27-014, 27-015, 27-030, 27-031, 27-032, 27-033, 27-041, 27-042, 27-043, 27-131, 27-132, 27-139, 27-140, 27-141, 27-153, 27-154, 27-155, 27-187, 27-199, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part of portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

ORDINANCE NO. 27-201

AN ORDINANCE RELATING TO HEALTH, REGULATING THE PRODUCTION, TRANSPORTATION, PROCESSING, HANDLING, SAMPLING, INSPECTION, EXAMINATION, GRADING, REGRADING, LABELING, DELIVERY AND SALE OF MILK AND MILK PRODUCTS, THE INSPECTION OF DAIRY HERDS, DAIRY FARMS, PUBLIC DAIRIES AND MILK PLANTS; INCORPORATING BY REFERENCE THE UNABRIDGED FORM OF THE MILK ORDINANCE AND CODE, 1963 RECOMMENDATIONS OF THE PUBLIC HEALTH SERVICE, U. S. DEPARTMENT OF HEALTH, EDUCATION AND WELFARE, BEING PUBLIC HEALTH SERVICE PUBLICATION NUMBER 229, EXCEPT SUCH PARTS OR PORTIONS OF SAID MILK ORDINANCE AND CODE AS ARE SPECIFICALLY CHANGED, OMITTED OR ADDED TO IN THIS ORDINANCE; PROVIDING FOR THE DUTIES OF THE HEALTH OFFICER OF THE CITY OF WICHITA, KANSAS IN ADMINISTERING AND ENFORCING THIS ORDINANCE; RESTRICTING THE GRADE AND QUALITY OF MILK AND MILK PRODUCTS WHICH MAY BE MOVED INTO, SOLD OR RECEIVED FOR HUMAN CONSUMPTION WITHIN THE CITY OF WICHITA, KANSAS OR ITS POLICE JURISDICTION; PROVIDING FOR MILK PERMITS AND REGULATORY CHARGES FOR SERVICES RENDERED UNDER THE TERMS OF THIS ORDINANCE; PROVIDING PENALTIES FOR VIOLATIONS OF SAID ORDINANCE; AND REPEALING CHAPTER 7.36 OF THE CODE OF THE CITY OF WICHITA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA:

SECTION ONE. The unabridged form of the Milk Ordinance and Code, 1963 Recommendations of the Public Health Service, U. S. Department of Health, Education and Welfare, Public Health Service Publication No. 229, is hereby incorporated by reference herein and made a part of this ordinance as if the same had been set out in full herein, except such parts or portions thereof as are specifically changed, omitted or added to in this ordinance; Provided, that the words "municipality of" in said unabridged form shall be understood to refer to the City of Wichita, Kansas; provided further, that in said unabridged form all parentheses marks, enclosing words referring to degrading, and footnotes referring thereto, shall be understood to be, and for the purpose of this ordinance, they shall be omitted.

SECTION TWO. Paragraph 7 of Section 1, and all of Sections 8, 11, 16, 17 and 18 of the Milk Code are hereby omitted from this Ordinance.

SECTION THREE. (a) As used in this ordinance, the term "police jurisdiction" refers to the jurisdiction of the City of Wichita, Kansas and its officers over all places within five (5) miles of the corporate limits of the City of Wichita, Kansas for the enforcement of health ordinances and regulations of the city.

(b) As used in this ordinance, the term "limits of routine inspection" shall include all milk plants and receiving stations located within the city, or its police jurisdiction, and shall further include all milk producers who hold valid
