SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 27-449

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Government Lot 6 and part of Government Lot 2 in the Northwest Quarter of Section 29 and an unplatted tract in the Southwest Quarter of Section 20, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the southwest corner of the Southwest Quarter of Section 20; thence north along the west line of said Southwest Quarter to the left bank of the Little Arkansas River; thence easterly along said left bank to the east line of the southwest quarter of said Southwest Quarter; thence south along said east line and the east line of the west half of Government Lot 2 and the east line of Government Lot 6 in the Northwest Quarter of Section 29 to the south line of said Government Lot 6; thence west along said south line to the west line of said Northwest Quarter; thence north along said west line to the point of beginning.

Provided, however, that this annexation is subject to the fulfillment, without franchise, restrictions, cost or tax to any party thereto, of any and all present contracts for supplying gas, oil, coal or other fuel, to any electric generating station located in the territory annexed by this Ordinance.

SECTION 2.
