SECTION 2. Such assessments with accrued interest, are levied concurrent with general property taxes, and shall be payable in ten equal installments and collected by special assessment upon the property liable therefor. The first of said installments shall be payable for the year 1965 and one installment for each year thereafter for the full term of ten years.

SECTION 3. All assessments shall bear interest at a rate of 4 per cent per annum.

SECTION 4. The owner of any property so assessed may at any time on or before December 7, 1964, pay the whole of the assessment against any lot or parcel to the City Clerk. If not paid on or before said date, said assessment will draw interest at the rate of 4 per cent per annum from such date, and be payable in the manner set forth in Section 2 hereof.

SECTION 5. Assessments not paid prior to the date provided in Section 4 herein, shall be certified, together with the interest accrued or to accrue, by the City Clerk to the County Clerk and collected in the same manner as other taxes.

SECTION 6. This ordinance shall take effect and be in force as of and on December 7, 1964, and after its passage and publication once in the official city paper.

ORDINANCE NO. 27-917

AN ORDINANCE INCORPORATING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF
WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

31st Street South right of way in the SE $\frac{1}{4}$ of Section 2, the NE $\frac{1}{4}$ of Section 11, the SW $\frac{1}{4}$ of Section 1, and the NW $\frac{1}{4}$ of Section 12, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the east line of Oliver Street and the north line of 31st Street South; thence west along said north line to the westerly right-of-way line of the Kansas Turnpike; thence southwesterly along said right-of-way line to the south line of 31st Street South; thence east along said south line to the east line of Oliver Street; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this Ordinance, together with the lands specified within Section 1 of Ordinance No. 27-461 be and same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this Ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this Ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to G. S. 1963 Supp., 12-517 et seq.

SECTION 5. This Ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.



ORDINANCE NO. 28-919

AN ORDINANCE AMONG OTHER THINGS THE EXCAVATION, CURB, AND PAVING ON ORIENT BOULEVARD FROM THE EAST LINE OF MERIDIAN AVENUE TO THE WEST LINE OF SENECA STREET.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA:

SECTION 1. That it is a public necessity to excavate, curb and pave Orient Boulevard from the East line of Meridian Avenue to the west line of Seneca Street in the City of Wichita, Kansas, said pavement shall consist of a CONCRETE PAVEMENT, six (6) inches thick.
