

## ORDINANCE NO. 27-964

AN ORDINANCE VACATING THE ALLEY BETWEEN LOT 16 AND LOTS 11 TO 17 INCLUSIVE, BLOCK A, McEWEN FIFTH ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the alley described as follows, to-wit:

The alley lying between Lot 18 and Lots 11 to 17 inclusive, Block A, McEwen's Fifth Addition, Wichita, Sedgwick County, Kansas,

be and the same is hereby vacated.

SECTION 2. That it is hereby recommended to the Board of County Commissioners of Sedgwick County, Kansas, that said above described land be vacated by said Board in case a proper petition is filed under the provisions of Sections 12-504, 12-505 and 12-506 of the General Statutes of Kansas, 1949, as amended.

SECTION 3. This ordinance shall be in force and take effect from and after its passage and publication once in the official city paper.

## ORDINANCE NO. 27-965

AN ORDINANCE DECLARING, ESTABLISHING AND DEFINING THE CITY LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AFTER A L. ANNEXATIONS OF TERRITORY, AND EXCLUSIONS OF TERRITORY SINCE JANUARY 1, 1964.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That hereafter and until altered or changed in accordance with the law, the city limits are, and the entire boundaries of the City of Wichita, Kansas, are hereby defined, established and declared to be as follows:

Beginning at the center of Section 18, Township 27 South, Range 2 East of the 6th P.M., being the Southeast Corner of First Addition to Pine Valley Estates; thence north along the east line of the Northwest Quarter of said Section 18 and the east line of the Southwest Quarter of Section 2, Township 27, South, Range 2 East of the 6th P. M., to the south line of the St. Louis and San Francisco Railroad Right-of-way; thence west along said right-of-way line to the east line of Government Lot 2 in the Northwest Quarter of said Section 2, extended from the north; thence north along said east line to the north line of said Government Lot 2; thence west along said north line to the east line of Woodlawn Boulevard; thence north along said east line to the north line of Third Addition to Crestview Heights, extended from the west; thence west along the north line of said Addition to the west line of said Addition; thence south along the west line of said Addition to the north line of First Street; thence west along the north line of First Street to the east line of the Southwest Quarter of Section 1, Township 27 South, Range 2 East of the 6th P. M.; thence north along said east line to the north line of said Southwest Quarter; thence west along said north line to the east line of Olive Avenue; thence north along said east line

to the south line of the Southwest Quarter of Section 36, Township 26 South, Range 1 East of the 6th P. M.; thence east along said south line to a point 414.3 feet east of the east line of the west half of said Southwest Quarter; thence north 841.5 feet; thence west 413.6 feet to the east line of the west half of said Southwest Quarter; thence north along said east line to a point 1963 feet north of the south line of said Southwest Quarter; thence west to the west line of Oliver; thence south to the north line of Chisholm Park Estates; thence west along said north line to the west line of the Southeast Quarter of Section 35, Township 26 South, Range 1 East of the 6th P. M.; thence south along said west line and the west line of the Northeast Quarter of Section 2, Township 27 South, Range 1 East of the 6th P. M. to the north line of Charron's Garden Addition as extended from the west; thence west along the north line of Charron's Garden Addition as extended and the north line of Charron's Garden Addition to the east line of Hillside Avenue; thence north along said east line to the north line of the Southeast Quarter of Section 34, Township 26 South, Range 1 East of the 6th P. M., extended from the west; thence west along the north line of the south half of said Section 34 and the south line of the Northeast Quarter of Section 33, Township 26 South, Range 1 East of the 6th P. M. to the east line of the west half of said Northeast Quarter; thence north along said east line to the north line of said Section 33; thence west along said north line to the west line of Cleveland Avenue extended from the north; thence north to the north line of 37th Street; thence west along said north line to the east right-of-way line of the St. Louis-San Francisco Railroad; thence north along said right-of-way line to the southerly right-of-way line of the Chisholm Creek Diversion; thence southwesterly along said right-of-way line to the east right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence north along said right-of-way line to the north line of the southeast quarter of the Southeast Quarter of Section 29, Township 26 South, Range 1 East of the 6th P. M. extended from the west; thence west along said north line to the east right-of-way line of U. S. M.; thence west along said north line to the east line of Reserve "A", Gifford Addition; thence southwesterly and northwesterly along the southerly line of said Reserve "A" to the north line of said Northeast Quarter; thence west along said north line to the west line of the Northeast Quarter of said Northeast Quarter; thence south along said west line to a point ninety and six-tenths (90.6) feet north of the south line of the Northeast Quarter of said Northeast Quarter; thence west a distance of three hundred thirty-four and one-tenth (334.1) feet; thence south a distance of one thousand four hundred nineteen (1419) feet to the south line of said Northeast Quarter one thousand six hundred fifty (1650) feet west of the southeast corner of said Northeast Quarter; thence west along said south line to the west line of the Southeast Quarter of said Section 30; thence south along said west line to the northerly right-of-way line of Interstate Highway 235; thence westerly and southerly along said right-of-way line to the south line of the Southeast Quarter of Section 25, Township 26 South, Range 1 West of the 6th P. M.; thence west along said south line to the west right-of-way line of Interstate Highway 235; thence southerly along said right-of-way line to the north line of the Southwest Quarter of Section 2, Township 27 South, Range 1 West of the 6th P. M.; thence southwesterly to the point of intersection of the west line of the Flood Control right-of-way along the right bank of the Big Arkansas River and the east right-of-way of the Flood Control Ditch; thence southwesterly and southeasterly along the east right-of-way of the Flood Control Project to the west line of Hoover Street as platted in Section 28, Township 27 South, Range 1 West; thence south along the west line of Hoover Street to the north line of Section 27, Township 27 South, Range 1 West of the 6th P. M., same being in Maple Street; thence west along said north line to the southeast corner of Section 21, Township 27 South, Range 1 West of the 6th P. M., to the south line of the north half of the Southwest Quarter of said Section 4; thence east along said south line to the west line of the Southeast Quarter of said Section 4; thence south to the southwest corner of said Southeast Quarter; thence east along the south line of said Southeast Quarter to a point five hundred fifty-three and ninety-seven hundredths (553.97) feet east of the northwest corner of the Northeast Quarter of Section 9, Township 28 South, Range 1 West of the 6th P. M.; thence south along a line parallel to and five hundred fifty-three and ninety-seven hundredths (553.97) feet east of the west line of said Northeast Quarter to the north right-of-way line of Kansas State Highway No. 42; thence northeasterly along said right-of-way to a point one hundred fifty-five and sixty-five hundredths (155.65) feet west of the east line of said Northeast Quarter; thence north along a line parallel to and one hundred fifty-five and sixty-five hundredths (155.65) feet west of the east line of said Northeast Quarter to the north line of said Northeast Quarter; thence east along said north line and the south line of the Southwest Quarter of Section 3, Township 28 South, Range 1 West of the 6th P. M., to the north right-of-way line of K-42 Highway; thence northeasterly along said right-of-way line to a point two hundred ten (210) feet west of the center line of said Section 3; thence north along a line parallel to and two hundred ten (210) feet west of said center line a distance of three hundred twenty-eight and three-tenths (328.3) feet; thence west at ninety (90) degrees a distance of three hundred ninety (390) feet; thence north along a line parallel to and six hundred (600) feet west of the center line of said Section 3 to a point three hundred twenty-seven and four-tenths (327.4) feet south of the southwest corner of the Northwest Quarter of the Northeast Quarter of said Section 3; thence east at ninety (90) degrees to a point on the center line of said Section 3 three hundred twenty-seven and four-tenths (327.4) feet south of the southwest corner of the Northwest Quarter of the Northeast Quarter of said Section 3; thence north to said southwest corner; thence east along the south line of the north half of the Northeast Quarter of said Section 3 and the south line of the Northwest Quarter of the Northwest Quarter of Section 2, Township 28 South, Range 1 West of the 6th P. M., to the west right-of-way line of the Wichita-Valley Center Flood Control Ditch; thence north one hundred (100) feet; thence west along a line parallel to and one hundred (100) feet north of the south line of the Northwest Quarter of said Northwest Quarter to the west line of said Northwest Quarter; thence north along said west line and the west line of Section 35, Township 27 South, Range 1 West of the 6th P. M., to the southwest corner of the Southwest Quarter of Section 26, Township 27 South, Range 1 West of the 6th P. M.; thence east to the east line of said Addition; thence northerly along said east line to the south line of the north half of the Northeast Quarter of said Southwest Quarter; thence east to the east line of said Southwest Quarter; thence north along said east line a distance of the north line of the Northwest Quarter of said Section 20 to the westerly right-of-way of the Midland Valley Railroad; thence north along said right-of-way line to the north line of said Section 20; thence east along said north line and the north line of Section 21, Township 28 South, Range 1 East of the 6th P. Northeast Quarter of said Section 21; thence south along said west line to the north line of the Southeast Quarter of said Section 21; thence west along said north line to the east line of the Kansas Turnpike; thence southerly along said right-of-way line to the south line of the north half of the north half of said Southeast Quarter; thence east along said south line to the west line of the Southwest Quarter of Section 22, Township 28 South, Range 1 East of the 6th P. M.; thence east along said south line to the east line of said Railroad; thence north along said east line to the north line of said Southwest Quarter; thence east along said north line to the westerly right-of-way line of the Kansas Turnpike; thence northeasterly along said right-of-way line to the south line of 31st Street South; thence east along said south line to the east line of the County Road adjacent to and east of the Kansas Turnpike; thence southwesterly along said east line to a point three hundred ninety (390) feet south of the north line of the Northeast Quarter of Section 11, Township 28 South, Range 1 East; thence east parallel to and three hundred ninety (390) feet south of said north line to a point three hundred sixty (360) feet east of the west line of the Northeast Quarter of the Northeast Quarter of said Northeast Quarter; thence north parallel to said west line a distance of one hundred twenty-six (126) feet; thence east parallel to the north line of said Northeast Quarter to the east line of Oliver Street; thence north along said east line to the north line of 31st Street South; thence east along said north line to the east line of the Southwest Quarter of Section 1, Township 28 South, Range 1 East of the 6th P. M.; thence north along said east line to the north line of said Southwest Quarter; thence west along said north line to the east line of George Washington Boulevard; thence northwesterly along said east line to the south right-of-way line of the Kansas Turnpike; thence northeasterly along said right-of-way line to a line 300 feet south and parallel to the south line of Pawnee Avenue; thence east on said line to the east line of the Northwest Quarter of said Section 1; thence north to the northerly right-of-way line of the Kansas Turnpike; thence northeasterly along said right-of-way line to the east line of the west half of the Northwest Quarter of Section 31, Township 27 South, Range 2 East of the 6th P. M.; thence north along said east line to the center line of Harry Street; thence west along said center line to the west line of Woodlawn Boulevard; thence north along said west line to the south line of Bayley Street extended from the east; thence east along said south line to the west line of the Southeast Quarter of Section 30, Township 27 South, Range 2 East of the 6th P. M.; thence south along said west line to the south line of said Southeast Quarter; thence east along said south line to the center line of Broadmoor Avenue; thence south to the south line of Harry Street; thence east along the south line of Harry Street to the east line of Lynncrest Heights Addition extended from the north; thence north to the south line of the Southwest Quarter of Section 29, Township 27 South, Range 2 East of the 6th P. M.; thence east along said south line to the east line of said Southwest Quarter; thence north along said east line and the east line of the Northwest Quarter of said Section 29 to the south right-of-way line of the Kansas Turnpike; thence easterly along said right-of-way line to the south line of the northwest quarter of the Northeast Quarter of Section 27, Township 27 South, Range 2 East of the 6th P. M.; thence east along said south line to the east line of the Northwest Quarter of said Northeast Quarter; thence north along said east line and said line extended to the north right-of-way line of U. S. Highway 54; thence west along said right-of-way line to a point seven hundred twenty-six (726) feet east of the west line of the Southeast Quarter of Section 22, Township 27 South, Range 2 East of the 6th P. M.; thence north parallel to said west line to a point one thousand three hundred twenty (1320) feet north of the south line of said Southeast Quarter; thence west parallel to said south line to the west line of said Southeast Quarter; thence north to the northeast corner of the south half of the Southwest Quarter of said Section 22; thence west along the north line of the south half of said Southwest Quarter and the north line of the Southeast Quarter of the Southeast Quarter of Section 21, Township 27 South, Range 2 East of the 6th P. M., to the west line of the Southeast Quarter of said Southeast Quarter; thence north along said west line to the north line of U. S. Highway 54; thence west along said north line to the west line of Webb Road; thence north along said west line to the north line of Central Avenue; thence west along said north line to the east line of said Addition to Wickridge; thence north along said east line to the north line of said Addition; thence west along said north line, to the north line of said Addition to Wickridge and the north line of the Southeast Quarter of Section 28, Township 27 South, Range 2 East of the 6th P. M. to the point of beginning.

SECTION 2. That the following blocks, parcels, pieces and tracts of land be and they are hereby excluded from the corporate limits of the City of Wichita, even though completely surrounded by the territory of the City of Wichita and nothing herein shall otherwise be construed as a derogation or exclusion of such blocks, parcels, pieces and tracts of land within the city limits, such lands being described as follows:

(a) Beginning at the intersection of the north line of Kellogg Street and the west line of Woodlawn Boulevard; thence north along said west line to the center line of Douglas Avenue; thence west along said center line to the west line of Woodlawn Heights Addition; thence north along said west line a distance of six hundred fifty-five (655) feet; thence east three hundred seventy-seven (377) feet; thence north six hundred fifty-five (655) feet more or less, to the north line of the South half of the Northeast Quarter of Section 24, Township 27 South, Range 1 East of the 6th P. M.; thence east along said north line and the south line of Cresthill Manor Addition to the east line of the West half of Section 19, Township 27 South, Range 2 East of the 6th P. M.; thence south along said east line to the south line of Block U, Eastborough 3rd Addition; thence west to the east line of Block DZ, in said Addition, extended from the south; thence south along said east line and the east line of Block EZ, in said Addition to the north line of Kellogg Street; thence west to the point of beginning.

SECTION 3. That the territory embraced within the limits and boundaries described in Section 1 hereof is the territory included within Section 1 of Ordinance No. 27-461 effective December 31, 1963, plus the territory specified and described in Section 1 of Ordinances No'd 27-918, 27-939, 27-940, 27-941, and 27-942.

SECTION 4. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those theretofore established by law.

SECTION 5. That Section 1 of Ordinance No. 27-461 and all other ordinances and parts of ordinances inconsistent with or in conflict with the terms and provisions hereof be and the same are hereby repealed.

SECTION 6. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 27-966

AN ORDINANCE APPROPRIATING THE AMOUNTS SET UP IN EACH FUND IN THE BUDGET FOR THE YEAR 1965; PROVIDING FOR THE PAYMENT OF ALL CLAIMS AND CHARGES AGAINST THE ACCOUNTS PROVIDED FOR THEREIN; AND APPROVING AND RATIFYING THE PAYMENT OF ALL CLAIMS AGAINST THE ACCOUNTS FOR THE YEAR 1964.

BE IT ORDERED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That there is hereby appropriated the amounts set up in each fund in the budget for all the fiscal year 1965, for the payment of all claims and charges against each such fund. Payments of all claims and charges against each such fund shall be made by combination checks and warrants, drawn by the Director of Administration and countersigned by the City Manager as is provided by law. Provided, however, that such officer shall at all times comply with the provisions of the Budget law and the Cash Receipts Law of the State of Kansas.
