## ORDINANCE NO. 28-485

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in Section 1, Township 27, South, Range 1, East of the 6th P. M., more fully described as follows:

Beginning at the center of Section 1, Township 27, South, Range 1, East of the 6th P. M.; thence west along the south line of the Northwest Quarter of said Section 1 to the east line of Oliver Avenue; thence north along said east line to the north line of said Section 1; thence east along said north line to the east line of said Section 1; thence south along said east line to the north line of Third Addition to Crestview Heights; thence west along said north line to the west line of said Addition; thence south along said west line to the north line of 21st Street; thence west along said north line to the east line of the Southwest Quarter of said Section 1; thence north to the point of beginning.

SECTION 2. That the land specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance No. 28-432, Section 1 of Ordinance No. 28-453, Section 1 of Ordinance No. 28-460, and Section 1 of Ordinance No. 28-471, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-517, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

SECTION 1. That it is hereby declared to be a public necessity and convenience to eliminate confusion in the name of the following named street in the City of Wichita, Kansas, and the name of such street should be, and the same is hereby changed from and after the effective date of this Ordinance, and shall be known, named, and designated by the new name as follows, to-wit:

That portion of SHERIDAN AVENUE between the north line of Central Avenue and the south right-of-way line of the Missouri-Pacific Railroad, be changed to BICKEL STREET.

SECTION 2. That all ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed.

SECTION 3. That this Ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
