ORDINANCE NO. 28-684

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Levitt Industrial Park in the Northeast Quarter of Section 31, Township 27, South, Range 2, East of the 6th P. M., more fully described as follows:

Beginning at the point of intersection of the south line of Harry Street and the west line of Rock Road; thence south along said west line to a point one thousand three hundred twenty-one (1321) feet south of the north line of the Northeast Quarter of Section 31; thence west parallel with said north line five hundred forty-nine and twenty-one hundredths (549.21) to a point seven hundred eleven (711) feet east of the west line of the east half of said Northeast Quarter, said point being the point of curvature of a curve to the left having a central angle of thirty-seven (37) degrees forty (40) minutes and a radius of five hundred fifty-one and two-tenths (551.2) feet; thence southwesterly along said curve three hundred sixty-two and thirty-six hundredths (362.36) feet to the point of reverse curve of a curve to the right having a central angle of thirty-seven (37) degrees forty (40) minutes and a radius of two hundred sixteen and forty-six hundredths (216.46) feet; thence along said curve one hundred forty-two and three-tenths (142.3) feet to the point of a compound curve to the right having a central angle of thirty-eight (38) degrees thirty-four (34) minutes and a radius of three hundred eighty-eight and five hundredths (388.05) feet; thence along said curve two hundred sixty-one and twenty hundredths (261.20) feet to the west line of the east half of said Northeast Quarter; thence north along said west line to the south line of Harry Street; thence east to the point of beginning.

SECTION 2. That the land specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 28-432, 28-453, 28-460, 28-471, 28-485, 28-588, 28-589, 28-614, 28-615, 28-616, 28-634, 28-654, 28-682 and 28-683, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 17-111, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

AN ORDINANCE MAKING A SPECIAL ASSESSMENT TO PAY FOR THE COST OF ABATING CERTAIN PUBLIC HEALTH NUISANCES UNDER THE PROVISIONS OF SECTION 7.40.05C OF THE CODE OF THE CITY OF WICHITA.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1.
