ORDINANCE NO. 28-702

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Arkansas River in the south half of the north half of Section 25, Township 26, South, Range 1, West of the 6th P. M., more fully described as follows:

Beginning at the point of intersection of the south line of the north half of Section 25, Township 26, South, Range 1, West of the 6th P. M., and the east mean high bank of the Arkansas River; thence northerly along said high bank to the north line of the south half of the north half of said Section 25; thence west to the west mean high bank of the Arkansas River; thence southerly along said high bank to the south line of the north half of said Section 25; thence east to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 28-432, 28-453, 28-460, 28-471, 28-485, 28-588, 28-589, 28-614, 28-615, 28-616, 28-634, 28-654, 28-682, 28-683 and 28-684, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-517, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

AN ORDINANCE AMENDING THE 1966-1971 CAPITAL IMPROVEMENT PROGRAM AND THE 1966 CAPITAL IMPROVEMENT BUDGET OF THE CITY OF WICHITA, KANSAS, AND REPEALING ORDINANCE NO. 28-267.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:
