

ORDINANCE NO. 35-708

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

Part of Section 17, Township 27 South, Range 1 West
of the 6th P. M., more fully described as follows:

Beginning at a point on the east line of Maize Road
and eight hundred seventy (870) feet north of the
south line of the Northwest Quarter, Section 17,
Township 27 South, Range 1 West of the 6th P. M.;
thence east parallel to the south line of said
Northwest Quarter to a point four hundred and fifty-
five hundredths (400.55) feet east of the west
line of said Northwest Quarter; thence south parallel
with the west line of said Northwest Quarter to the
south line of said Northwest Quarter; thence east
along the south line of said Northwest Quarter to
the Northwest Corner of the East Half of the West
Half of the Southwest Quarter of Section 17, Town-
ship 27 South, Range 1 West of the 6th P. M.; thence
south along the west line of the East Half of the
West Half of said Southwest Quarter to a point four
hundred sixty-two (462) feet north of the south line
of the North Half of said Southwest Quarter; thence
west parallel to the south line of the North Half of
said Southwest Quarter to the east line Maize Road;
thence north along said east line to the point of
beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 35-347, 35-388,
35-514, 35-582, 35-602, 35-603, AND 35-604

be and the same are hereby declared to constitute the lands
within the corporate limits and boundaries of the City of Wichita,
Kansas.

SECTION 3. That if any part or portion of this ordinance
shall be held or determined to be illegal, ultra vires or void
the same shall not be held or construed to alter, change or annul

any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

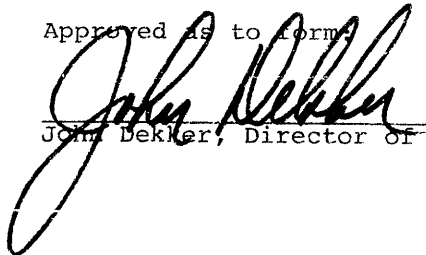
