

ORDINANCE NO. 36-934

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having adopted a resolution on September 16, 1980, indicating the City was considering annexation, and after having given notice in writing to all property owners, having published notice in The Daily Record, the official newspaper of Wichita; and after having held a public hearing and having prepared a plan for extension of services into the area to be annexed, all as required by law, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in the Southwest Quarter of Section 36, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

The West Half of said Southwest Quarter, except the South one thousand nine hundred sixty-three (1,963) feet thereof, and except the North two hundred twenty-six (226) feet of the South two thousand four hundred thirty-four and seventy-five hundredths (2,434.75) feet of the West Half thereof.

AND

A tract of land in Section 36, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the intersection of the East Line of Oliver and the Northerly Right-of-Way Line of the Missouri Pacific Railroad; thence south along the East Line of Oliver to a point five hundred fifty-two and ninety-two hundredths (552.92) feet North of the South Line of the Northwest Quarter of said Section 36; thence with a deflection to the left of eighty-six degrees thirty-five minutes six seconds (86° 35' 06") for a distance of eight hundred forty-six and fifty hundredths (846.50) feet; thence with a deflection to the right of four degrees thirty-three minutes fifty-nine seconds (4° 33' 59") for a distance of nine hundred forty-four and thirty hundredths (944.30) feet; thence with a deflection to the left of five

degrees forty-five minutes fifty-six seconds (5° 45' 56") for a distance of four hundred seventy and thirty-seven hundredths (470.37) feet to a point two thousand three hundred nine and eighteen hundredths (2,309.18) feet South and three hundred thirty (330) feet West of the Northeast Corner of the Northwest Quarter of said Section 36; thence North parallel to the East Line of said Northwest Quarter to the North Line of the South Half of said Northwest Quarter; thence East along said North Line to the East Line of said Northwest Quarter; thence North along said East Line to a point six hundred sixty (660) feet South of the North Line of said Northwest Quarter; thence West parallel to said North Line to a point three hundred thirty (330) feet West of the East Line of said Northwest Quarter; thence North parallel to said East Line to the South Line of 37th Street North; thence West along said South Line to the Northerly Right-of-Way Line of the Missouri Pacific Railroad; thence Southwesterly along said Northerly Right-of-Way Line to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 36-392, 36-399, 36-424, 36-425, 36-437, 36-438, 36-579, 36-580, 36-581, 36-582, 36-597, 36-609, 36-610, 36-611, 36-612, 36-669, 36-677, 36-695, 36-708, 36-900, 36-901, 36-932, and 36-933

be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.


SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official

city paper.


