

ORDINANCE NO. 37-512

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having adopted a resolution on May 5,
1981, indicating the City was considering annexation, and after
having given notice in writing to all property owners, having pub-
lished notice in The Daily Record, the official newspaper of Wichita;
and after having held a public hearing and having prepared a plan
for extension of services into the area to be annexed, all as re-
quired by law, the following blocks, parcels, pieces and tracts of
land be and they are hereby included and brought within the corporate
limits of the City of Wichita, Kansas:

Tracts of land in the Southeast Quarter of Section
25, Township 27 South, Range 2 West of the 6th
P.M., more fully described as follows:

Beginning at the intersection of the East Line of
Wheatridge Drive with the North Line of Lynndale
Street; thence South along the East Line of Wheat-
ridge Drive to the North Line of Bledsoe Addition
to Sedgwick County, Kansas; thence East along said
North Line to a line lying parallel to and two hun-
dred twenty-five (225) feet West of the East Line
of the Southeast Quarter of Section 25, Township
27 South, Range 2 West of the 6th P.M.; thence
North parallel with said East Line to the South
Line of Lynndale Street; thence Northerly to a
point on the North Line of Lynndale Street said
point being two hundred twenty-five and six tenths
(225.6) feet West of the East Line of said South-
east Quarter; thence North parallel with said East
Line to the South Line of J. D. Owens Addition to
Sedgwick County, Kansas; thence West along said
South Line and said line extended to a point two
hundred eighteen and four tenths (218.4) feet West
of the West Line of Wheatridge Drive; thence South
parallel with said West Line of Wheatridge Drive
to the North Line of Lynndale Street; thence East
along said North Line to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 36-955, 36-371,
36-372, 37-155, 37-156, 37-170, 37-171, 37-224, 37-323, 37-331,
37-338, 37-339, 37-353, 37-381, 37-382, 37-431, 37-483,
37-484, 37-499, & 37-503

be and the same are hereby declared to constitute the lands

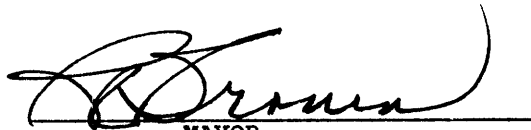
within the corporate limits and boundaries of the City of
Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

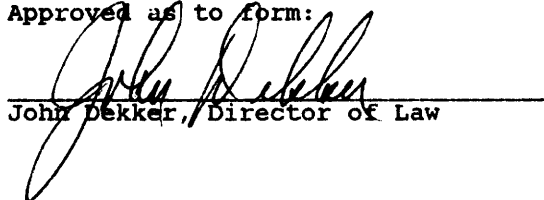
