

ORDINANCE NO. 37-908

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

Tracts of land in Sections 28 and 33, Township 27
South, Range 2 East of the 6th P.M., Sedgwick
County, Kansas, more fully described as follows:

Beginning at the intersection of the North Line of
Harry Street with the East Line of the Southwest
Quarter of Section 28, Township 27 South, Range 2
East of the 6th P.M.; thence West along the North
Line of Harry Street to the extended West Line of
Cranbrook Avenue as platted in Red Oaks First
Addition to Sedgwick County, Kansas; thence South
along said extended West Line to the South Line of
the Northwest Quarter of Section 33, Township 27
South, Range 2 East of the 6th P.M.; thence East
along said South Line to the East line of said
Southwest Quarter; thence North along said East
Line and the East Line of the Southwest Quarter of
Section 28, Township 27 South, Range 2 East of the
6th P.M., to the point of beginning; except for
Lots 7 and 8, Huntcrest Addition to Sedgwick County,
Kansas.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 37-615, 37-640, 37-641,
37-642, 37-643, 37-686, 37-687, 37-877 + 37-878 be and the same
are hereby declared to constitute the lands within the corporate
limits and boundaries of the City of Wichita, Kansas.

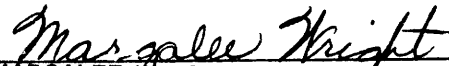
SECTION 3. That if any part or portion of this ordinance
shall be held or determined to be illegal, ultra vires or void
the same shall not be held or construed to alter, change or annul
any terms or provisions hereof which may be legal or lawful. And
in the event this ordinance in its entirety shall be held to be
ultra vires, illegal or void, then in such event the boundaries

and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

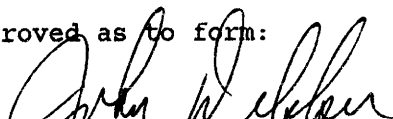
