ORDINANCE NO. 38-081

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in Sections 26 and 35, Township 26
South, Range 1 East of the 6th P.M. in Sedgwick
County, Kansas, more fully described as follows:

Beginning at a point on the South Line of 37th
Street North, said point being three hundred
ninety-seven (397) feet West of the East Line
of Section 35, Township 26 South, Range 1 East
of the 6th P.M.; thence North parallel to and
three hundred ninety-seven (397) feet West of
said East Line and said line extended to a point
forty (40) feet North of the North Line of said
Section 35; thence West parallel to and forty
(40) feet North of said North Line for a dis-
tance of five hundred fifty-one and six tenths
(551.6) feet; thence South parallel with the
extended East Line of Section 35, Township 26
South, Range 1 East of the 6th P.M. to the South
Line of 37th Street North; thence East along said
South Line of 37th Street North to the point of
beginning.

Also beginning at a point on the South Line of 37th
Street North, said point being one thousand one hun-
dred ninety-seven and thirty-one hundredths (1197.31)
feet West of the East Line of Section 35, Township
26 South, Range 1 East of the 6th P.M.; thence North
parallel to said East Line and said line extended to
a point forty (40) feet North of the North Line of
said Section 35; thence West parallel to and forty
(40) feet North of said North Line to a point five
hundred twenty-nine and six tenths (529.6) feet East
of the West Line of said Section 35; thence South
to the South Line of 37th Street North; thence East
to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified

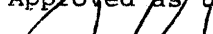
SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
