

ORDINANCE NO. 38-643

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in Section 11, Township 28 South,
Range 1 West of the 6th P.M., Sedgwick County,
Kansas, more fully described as follows:

Beginning at the intersection of the south
line of 31st Street South and the east right-
of-way line of the Wichita Valley Center flood
control ditch as condemned in Condemnation Case
A-30410; thence Southerly along said east line
to the south line of the Northwest Quarter of
Section 11, Township 28 South, Range 1 West of
the 6th P.M.; thence East along said south line
and the south line of the Northeast Quarter of
said Section 11 to the west right-of-way line of
the Missouri-Pacific Railroad; thence North along
said west right-of-way line to the Southerly
right-of-way line of Interstate 235 highway;
thence Northwesterly along said south line to the
south line of 31st Street South; thence West along
said south line to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinance No. 38-607,
be and the same are hereby declared to constitute the lands
within the corporate limits and boundaries of the City of
Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance
shall be held or determined to be illegal, ultra vires or void
the same shall not be held or construed to alter, change or annul
any terms or provisions hereof which may be legal or lawful. And
in the event this ordinance in its entirety shall be held to be
ultra vires, illegal or void, then in such event the boundaries

and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

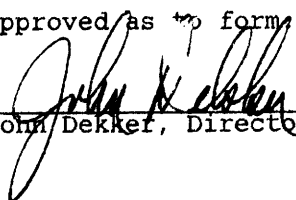
