ORDINANCE NO. ~~38-850~~

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in Section 8, Township 27
South, Range 1 West of the 6th P.M., Sedg-
wick County, Kansas, more fully described
as follows:

Beginning at the intersection of the south
line of 21st Street North and the east line
of the Northwest Quarter of Section 8, Town-
ship 27 South, Range 1 West of the 6th P.M.;
thence west along said south line of 21st
Street to a point 963.19 feet west of the
east line of said Northwest Quarter; thence
south parallel to the east line of said
Northwest Quarter to a point 1034.36 feet
south of the north line of said Northwest
Quarter; thence west parallel to the north
line of said Northwest Quarter to the east
line of Maize Road; thence south along said
east line to the north line of the West Towne
Baptist Church Addition to Sedgwick County;
thence east along said north line to the
Northeast corner of said Addition; thence
south along the east line of said Addition
to the Southeast corner of said Addition;
thence west along the south line of said
Addition to the east line of Maize Road;
thence south along said east line, a dis-
tance of 183.13 feet; thence east parallel
to the north line of said Northwest Quarter
to the east line of said Northwest Quarter;
thence north along said east line to the point
of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 38-607, ~~38-643~~,
~~38-755~~, ~~38-816~~, + ~~38-859~~ be and the same are hereby de-
clared to constitute the lands within the corporate limits and
boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

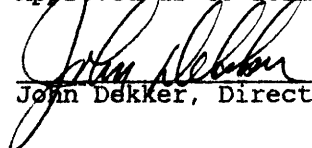
