ORDINANCE NO. 39-678

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in the Northwest Quarter of Section 7, Township 27 South, Range 1 West of the 6th P.M., Sedgwick County, Kansas, more fully described as:

Beginning at the northeast corner of Lot 65, Block 2, Echo Hills 2nd Addition to Wichita, said point being on the east line of said Northwest Quarter of Section 7; thence north along said east line of the south line of 21st Street North; thence west along said south line 210 ft.; thence south parallel to the east line of said Northwest Quarter 214 ft.; thence west parallel to the north line of said Northwest Quarter 285 ft., more or less to a point on the east line of Reserve A as platted in Echo Hills 2nd Addition to Wichita; thence south along said east line to the north line of Lot 60, Block 2 of said Addition; thence east along the north line of Lots 60, 62, 63, 64 and 65 of said Block 2 to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 39-342, 39-349, 39-369, 39-370, 39-506, 39-527, 39-557, 39-574, 39-624, 39-625, 39-676, & 39-677 be and the same are hereby declared to constitute the lands within

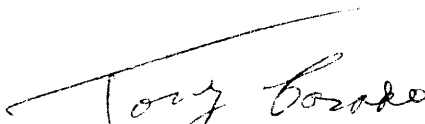
the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
