ORDINANCE NO. 39-840

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in the Northeast Quarter of
Section 33, Township 27 South, Range 2 East of the
6th P.M., Sedgwick County, Kansas, more fully de-
scribed as follows:

Beginning at the southwest corner of said North-
east Quarter Section; thence east along the south
line of said Northeast Quarter to the west line
of Greenwich Road; thence north along said west
line to the south line of Harry Street; thence
west along said south line to the northeast corner
of Smithmoor First Addition; thence south along
the east line of said Addition to the southeast
corner of said Addition; thence southwesterly
along the southerly line of said Addition to the
southwest corner of said Addition, said point
being on the west line of said Northeast Quarter;
thence south along said west line to the point
of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 39-728, 39-741, 39-764, 39-838, ~~39-839~~ be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
