

ORDINANCE NO. 22-372

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO. (P. 88-8)

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in Section 27, Township 26 South,
Range 1 East and Section 22, Township 26 South
Range 1 East of the 6th P.M., Sedgwick County,
Kansas described as:

Beginning at a point on the west line of Hillside
said point being 384.16 feet north of the inter-
section of the northwest right-of-way line of the
Rock Island Railroad and the westline of Hillside
located in the Northeast Quarter of Section 27,
Township 26 South, Range 1 East; thence north along
the west line of Hillside to a point 16.5 feet north
of the north line of the south half of the Northeast
Quarter of Section 22, Township 26 South, Range 1
East; thence west parallel to and 16.5 feet north of
said north line to the east line of the Northwest
Quarter of said Section 22; thence north along said
east line to the south line of 53rd Street North;
thence west along said south line to the west line
of the east half of said Northwest Quarter; thence
south along said west line of the east half to the
south line of said Northwest Quarter; thence east
along said south line to the Northwest corner of the
Southeast Quarter of said Section 22; thence south
along the west line of said Southeast Quarter to the
North line of 45th Street North; thence east along

said north line to the west line of Hillside; thence south along said west line to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 40-081, 40-187, 40-083, 40-153, 40-143, 40-153, 40-315, 40-324, 40-325, 40-326 and 40-354 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
