

ORDINANCE NO. 40-503

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES OF
THE CITY OF WICHITA, KANSAS, AND RELATING
THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF
WICHITA, KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the follow-
ing blocks, parcels, pieces and tracts of land be and they are
hereby included and brought within the corporate limits of the
City of Wichita, Kansas:

A tract of land in the Southwest Quarter of Section
22, Township 26 South, Range 1 East of the 6th P.M.,
Sedgwick County, Kansas, described as:

Beginning at the northeast corner of the Southeast
Quarter of the Southwest Quarter of Section 22,
Township 26 South, Range 1 East; thence west along
the north line of said Southeast Quarter of the
Southwest Quarter to the west line of the east half
of said Southeast Quarter; thence south along said
west line to a point 648.16 feet north of the south
line of said Southeast Quarter; thence east to a
point 647.7 feet north and 336 feet west of the
southeast corner of said Southeast Quarter; thence
south to a point on the north line of 45th Street
North, 342.47 feet west of the east line of said
Southeast Quarter; thence east along said north line
to the east line of said Southeast Quarter; thence
north along said east line to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified

and included within Section 1 of Ordinances No. 40-081, 40-082, 40-083,
40-103, 40-143, 40-153, 40-315, 40-324, 40-325, 40-326, 40-354, 40-370,
40-381, 40-387, 40-400, 40-407, be and the same are hereby declared
40-410, 40-446, 40-447, 40-448, & 40-449

to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.
