

ORDINANCE NO. 40-507

AN ORDINANCE INCLUDING AND INCORPORATING  
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS  
OF LAND WITHIN THE LIMITS AND BOUNDARIES OF  
THE CITY OF WICHITA, KANSAS, AND RELATING  
THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF  
WICHITA, KANSAS:

SECTION 1. That, after having received a request from the  
owners of said property for annexation by the City, the  
following blocks, parcels, pieces and tracts of land be and  
they are hereby included and brought within the corporate  
limits of the City of Wichita, Kansas:

A tract of land in Sections 13 and 14, Township 28  
South, Range 1 West of the 6th P.M., Sedgwick  
County, Kansas described as:

Beginning at intersection of the south line of the  
Northwest Quarter of Section 13, Township 28,  
South, Range 1 West and the east line of West  
Street; thence west along said south line and the  
south line of the Northeast Quarter of Section 14;  
Township 28 South, Range 1 West to the east line  
of the MoPac Railroad right-of-way; thence north  
along said east line 418.13 feet; thence east  
parallel to the south line of said Northeast  
Quarter to the west line of West Street; thence  
south along said west line to the south line of  
said Northeast Quarter; thence east along said  
south line and the south line of the Northwest  
Quarter of Section 13; Township 28 South, Range 1  
West to the point of beginning.

SECTION 2. That the lands specified and included within  
Section 1 of this ordinance, together with the lands specified

and included within Section 1 of Ordinances No. 40-081, 40-082, 40-083,  
40-103, 40-143, 40-153, 40-315, 40-324, 40-325, 40-326, 40-354, 40-370, 40-381,  
40-382, 40-400, 40-407, 40-410, 40-446, 40-447, be and the same  
40-448, 40-449, 40-503, & 40-506

are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.
