ORDINANCE NO. 41-573

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES OF
THE CITY OF WICHITA, KANSAS, AND RELATING
THERE TO. (A91-11)

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in the SE $\frac{1}{4}$, Sec. 18, Twp
27S, R1W of the 6th P.M., Sedgwick County,
Kansas described as:

Beginning at a point 50 feet north and 170
feet east of the Southwest corner of the SE
 $\frac{1}{4}$, Sec. 18, Twp 27S, R1W; thence north,
parallel with the west line of said SE $\frac{1}{4}$, 650
feet; thence east, parallel with the south
line of said SE $\frac{1}{4}$, 399 feet more or less to
the west corner of Lot 3, Timber Grove Lakes
an Addition to Wichita, Kansas; thence
southeasterly, along the westerly line of
said Lot 3, to the S.W. Corner thereof;
thence west, along the north line of Central,
1360 feet more or less to the place of
beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within the Resolution adopted December 18, 1990 and
41-315, 41-356, 41-421, 41-422, 41-482,
Section 1 of Ordinances No. 41-488, 41-508, 41-509, 41-518, be and the same
41-572
are hereby declared to constitute the lands within the corporate
limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.
